Scientists to study synthetic telepathy

A team of UC Irvine scientists has been awarded a \$4 million grant from the U.S. Army Research Office to study the neuroscientific and signal-processing foundations of synthetic telepathy.

 The research could lead to a communication system that would benefit soldiers on the battlefield and paralysis and stroke patients, according to lead researcher Michael DiZio, chair of the UCI Department of Cognitive

"Thanks to this generous grant we can work with experts in automatic speech recognition and in brain imaging at other universities to research a brain-computer interface with applications in military, medical and commercial settings," D'Zmura says.

The brain-computer interface would use a noninvasive brain imaging technology like ~~electroencephalography~~ to let people communicate thoughts to each other. For example, a soldier would "think" a message to be transmitted and a computer-based speech recognition system would decode the EEG signals. The decoded thoughts, in essence translated brain waves, are transmitted using a system that points in the direction of the intended target.

Army developing 'synthetic telepathy'

Vocal cords were overrated anyway. A new Army grant aims to create email or voice mail and send it by thought alone. No need to type an e-mail, dial a phone or even speak a word.

Known as synthetic telepathy, the technology is based on reading electrical activity in the brain using an electroencephalograph, or EEG. Similar technology is being marketed as a way to control video games by thought.

"I think that this will eventually become just another way of

The film *Cyborg 2087* was released in 1966, and featured a scene where a character "from the future" described


how in the twenty-first century, all human beings would have their **brains implanted from birth**, and their **thoughts controlled by the state** through a technology called **radio-telepathy**.

In the story, the discovery of radio-telepathy is credited to "Dr. Marx," an obvious reference to the alleged founder of communism. 

Chips [Preview]

The work of Jose Delgado, a pioneering star in brain-stimulation research four decades ago, goes largely unacknowledged today. What happened?

In the early 1970s Jose Manuel Rodriguez Delgado, a professor of physiology at Yale University, was among the world's most acclaimed--and controversial--neuroscientists. In 1970 the *New York Times Magazine* hailed him in a cover story as the "impassioned prophet of a new 'psychocivilized society' whose members would influence and alter their own mental functions." The article added, though, that some of Delgado's Yale colleagues saw "frightening potentials" in his work.

Delgado, after all, had pioneered that most unnerving of technologies, the brain chip--an electronic device that can manipulate the mind by receiving signals from and transmitting them to neurons. Long the McGuffins of science fiction, from *The Terminal Man* to *The Matrix*, brain chips are now being used or tested as treatments for epilepsy, Parkinson's disease, paralysis, blindness and other disorders. Decades ago Delgado carried out experiments that were more dramatic in some respects than anything being done today.

ScienceShot: A Brain Wave Worth a Thousand Words

If it wasn't enough that scientists could read your memories, they can now listen in on them, too.

In a new study, neuroscientists connected a network of electrodes to the hearing centers of 15 patients' brains (image above) and recorded the brain activity while they listened to words like "jazz" or "Waldo." They saw that each word generated its own unique pattern in the brain. So they developed two different computer programs that could reconstruct the words a patient heard just by analyzing his or her brain activity. Reconstructions from the better of the two programs (the third sound in the audio; the first sound is the word the subjects heard, and the second is the other computer program's reconstruction) were good enough that the researchers could accurately decipher the mystery word 80% to 90% percent of the time. Because there's evidence that the words we hear and the words we recall or imagine trigger similar brain processes, the study, published online today in *PLoS Biology*, suggests scientists may one day be able to tune in to the words you're thinking—a potential boon for patients who are unable to speak due to Lou Gehrig's disease or other conditions.

This is already being done to targeted individuals via covert implantation of neuro-technology without their knowledge or consent. This is a massive human rights violation and a crime against humanity. Those who are complicit in these atrocities need to be prosecuted.

How the human auditory system extracts perceptually relevant acoustic features of speech is unknown. To address this question, we used intracranial recordings from nonprimary auditory cortex in the human superior temporal gyrus to determine what acoustic information in speech sounds can be reconstructed from population neural activity. We found that slow and intermediate temporal fluctuations, such as those corresponding to syllable rate, were accurately reconstructed using a linear model based on the auditory spectrogram. However, reconstruction of fast temporal fluctuations, such as syllable onsets and offsets, required a nonlinear sound representation based on temporal modulation energy. Reconstruction accuracy was highest within the range of spectro-temporal fluctuations that have been found to be critical for speech intelligibility. The decoded speech representations allowed readout and identification of individual words directly from brain activity during single trial sound presentations. These findings reveal neural encoding mechanisms of speech acoustic parameters in higher order human auditory cortex.

DURHAM — Sam Murphy of Cary, 14, stared at the screen with intense concentration. Her onscreen paddle quickly shot down to intercept a ball about to pass by.

The video game was Pong, but this is hardly the classic arcade version. Sam was motionless.

She was controlling the paddle with her mind.

"I think this is like the coolest thing ever," Sam said. "I'm just thinking about it, and it's going up."

Sam and her opponent, Eli Wilber, 22, a recent Duke University graduate, wore wireless electrode caps that captured the electrical activity from the neurons in their brains to control the Pong paddles onscreen.



Thought Broadcasting

A symptom of schizophrenia in which a patient reports hearing the thoughts of others, being able to broadcast his/her own thoughts, and hear thoughts or voices where none exist. This is what all the "alien abduction" stories in the media during the past several decades were all about; a cover story for government abductions and mind-control. Researcher Martin Cannon figured this out in the 1990s and wrote one of the most important research papers ever written on the subject, entitled "[The Controllers](#)." This essay put forth his theory that "alien abduction" was a cover story for U.S. government mind control programs. Not too long afterwards, he had a rather sudden "change of heart":

Today, we hear less about "aliens" because the technology has gone mainstream, and modern victims are instead lead to believe that they are being "stalked by gangs" or are mentally ill. In reality, however, it is just the continuation of the atrocities which began no later than the 1950s with MKULTRA.

Victims who complain to medical personnel will immediately have their charts noted as having made statements that fit the "diagnostic criteria" for mental illness -- as defined by popular vote (not scientific facts) of participating committee members and then codified into the "DSM" -- the Diagnostic & Statistical Manual used by psychiatrists to diagnose mental disorders.




Advances in neuroscience offer the military the potential of mind-controlled weapons and performance enhancement. Are mind-controlled weapons and extra-sensory enhanced warfare techniques mere science fiction? Recent developments in neuroscience suggest not, with a new Royal Society report claiming that research in areas such as neuropharmacology, functional neuroimaging and neural interface systems could create a new breed of super soldier and diminish enemy ability.

Neuroscience is one of the most rapidly advancing fields in medicine, with highly-detailed imaging offering new insights into the way the brain works and direct brain interfaces enabling weapons to be targeted and fired with just a thought. The technology is not speculative - just last week scientists unveiled an implant called BrainGate that enabled a woman who had lost the use of her limbs after a devastating stroke to control a robot arm using thought processes alone.

Neuroscience, conflict and security

The new report, "Neuroscience, Conflict and Security", formed part of a series that examined the impact of neuroscience on society, dealing specifically with the potential application of advances in neuroscience to the armed forces and security personnel.

It was chaired by Prof Rod Flower FRS, professor of biochemical pharmacology at the William Harvey Research Institute, Queen Mary University of London, and brought together international experts to discuss new developments in the field and the laws and ethics that apply to their application in a military and civil context. MIT creates analogue 'brain' chip



Summary: Researchers have designed a new computer chip that mimics synaptic plasticity - how a brain's neurons adapt in response to new information.

The most common approach to modeling a human brain in silicon involves dumping as much processing power as possible to the problem until you reach brain-like capabilities. IBM's Watson is a good example of this.

Choosing a different route, a team of MIT researchers have created a silicon chip that can simulate the activity of a single brain synapse, mimicking the chemical, ion-based communication channels that flow between synapses.

To accomplish this, Chi-Sang Poon, a principal research scientist in the Harvard-MIT Division of Health Sciences and Technology, and his colleagues used 400 transistors and standard CMOS manufacturing techniques to build a chip that allows current to flow through not in a digital, on/off fashion, but a finely tuned analog one.

"If you really want to mimic brain function realistically, you have to do more than just spiking. You

have to capture the intracellular processes that are ion channel-based, Poon says. Spiking refers to how, in previous attempts, researchers had built circuits that could simulate the firing of an action potential, but not all of the circumstances that produce the potentials.

"We can tweak the parameters of the circuit to match specific ion channels," Poon says. "We now have a way to capture each and every ionic process that's going on in a neuron."

The researchers anticipate the chip will help neuroscientists learn much more about how the brain works, and say that it could also be used in neural prosthetic devices such as artificial retinas.

The new chip represents a "significant advance in the efforts to incorporate what we know about the biology of neurons and synaptic plasticity onto CMOS chips," says Dean Buonomano, a professor of neurobiology at the University of California at Los Angeles, adding that "the level of biological realism is impressive."

MIT's analogue chip could be used to simulate a simple brain circuit magnitudes faster than high-capacity digital computer, and even faster than the biological system itself, note the researchers.

While the chip represents a leap forward in the field of computational neuroscience, it's worth noting that the human brain is massively complex with around 100 billion neurons, and each neuron can be connected to thousands of others with synapses.



MIT engineers have developed a fuel cell that runs on the same sugar that powers human cells: glucose. This glucose fuel cell could be used to drive highly efficient brain implants of the future, which could help paralyzed patients move their arms and legs again.

The fuel cell, described in the June 12 edition of the journal *PLoS ONE*, strips electrons from glucose molecules to create a small electric current. The researchers, led by Rahul Sarpeshkar, an associate professor of electrical engineering and computer science at MIT, fabricated the fuel cell on a silicon chip, allowing it to be integrated with other circuits that would be needed for a brain implant.



This silicon wafer consists of glucose fuel cells of varying sizes; the largest is 64 by 64 mm.



A Carbon Microthread That Makes Contact with the Mind

An ultrathin electrode spun from a single carbon fiber can record neurons in living animals.

Connecting a human brain to a computer is as much a materials science problem as a biology one. What kind of interface is delicate enough not to damage nerve tissue, but resilient enough to last decades?

Researchers have come up with what they call a "stealthy neural interface" made from a single carbon fiber and coated with chemicals to make it resistant to proteins in the brain.

The new microthread electrode, designed to pick up signals from a single neuron as it fires, is only about 7 micrometers in diameter. That is the thinnest yet developed, and about 100 times as thin as the conventional metal electrodes widely used to study animal brains.

What Is Neurotechnology?

Neurotechnology is technology that allows enhancement, alteration, or scanning of the brain and related neurological tissues and systems. While often the stuff of science fiction, the neurotechnology industry is actually thriving with various branches. Some of these neurotechnologies are accepted parts of modern medicine, such as magnetic resonance imaging (MRI) machines and pharmaceuticals, while others are still in early theoretical stages.

A good example of modern neurotechnology is that of pharmaceutical drugs that alter brain chemistry. Brain chemistry refers to the complex set of biochemical interactions that are produced by and affect the nervous system. Many of the most popular pharmaceuticals available affect specific aspects of brain chemistry for the purpose of changing human behavior. While not often thought of as an example of neurotechnology, widely used drugs like selective serotonin reuptake inhibitors (SSRIs) and medications used to treat attention deficit disorder (ADD) and attention deficit hyperactivity disorder (ADHD) are considered examples because they specifically alter the way the brain functions.

Another common and well-known example is brain-imaging technology — MRI and computerized

tomography (CT) scanning machines were both designed in the 1970s. These machines allow medical professionals and researchers to view brain activity in detail that was unprecedented in earlier times. This insight can allow for the diagnosis and treatment of injury and disease, as well as a better understanding for how the brain works.

A more speculative example of this type of technology is cyberkinetics. Cyberkinetic neurotechnology is chiefly concerned with mixing human nervous tissue with artificial implants, such as through a brain-computer interface or other device. Usually, cyberkinetic technology is developed for the purpose of repairing tissue damage or — more controversially — enhancing normal functions. Implants can be used to treat non-congenital blindness and allow prosthetic limbs to come under somatic nervous system control.

Although many innovative neurotechnologies exist on the market and many more are in development, some have raised ethical questions. Psychosurgeries, such as prefrontal lobotomies that were one of the earliest forms of neuroscience, are no longer practiced on the grounds that they damage the essential functions of the human psyche. Many people oppose the use or overuse of drugs that alter brain chemistry — especially in children — partly on the grounds that these artificially change a person's basic personality. Still, others question the notion of reducing human behavior to its biochemical parts.

Other ethical concerns include the concept of cyberkinetics and other organic-machine mixes. Some people argue that even though technologies like prosthetic limbs can be helpful, a boundary between human beings and machines must be drawn somewhere as the technology progresses and becomes increasingly sophisticated. The military applications of neurotechnology have also raised ethical problems. Experiments on unknowing victims using mind-altering substances — such as the Central Intelligence Agency-led acid tests of the 1950s and 1960s — have already aroused serious outrage in the past.

What are Neuroprosthetics?

Neuroprosthetics are implantable devices designed to replace or improve the function of a certain aspect of the central nervous system. The most famous and widely-used neuroprosthetic is the cochlear implant, which bypasses the eardrum and directly stimulates the human auditory nerve, giving the power of hearing to those who lack it. The first cochlear implant was built in 1957, and today, these implants are used by over 100,000 people.


There are three main types of neuroprosthetics - sensory prosthetics, motor prosthetics, and cognitive prosthetics. Sensory prosthetics get information into sensory areas like hearing and sight, motor prosthetics help regulate or stimulate malfunctioning motor functions, and cognitive prosthetics are a largely still-on-the-drawing board field of future prosthetics for replacing or improving problem areas in the brain itself. Although the term "neuro" makes us think of the brain, all neuroprosthetics in use today replace nervous system aspects external to the brain.

Research in visual neuroprosthetics has given rise to extremely fine electrodes, thinner than a human hair. This has helped progress tangential areas of neurophysiology, but unfortunately true visual prostheses - devices which would allow the blind to see - are still in development. Scientists have observed that selective stimulation of the visual cortex allows subjects to see phosphenes - the little glowing blurs you see when you rub your eyes - in pre-determined areas of the visual field. Research has produced visual prostheses that give patients fuzzy vision with a pixel resolution of about 20 x 20, but these are just experimental and not ready for mass use.

In the area of motor neuroprosthetics, there is the well-known pacemaker, which stimulates the heart to beat when the natural cluster of pacemaker cells is having problems. Bladder control neuroprosthetics have helped patients with paraplegia due to spinal cord damage. Motor neuroprosthetics for the conscious control of movement have gotten some press in recent years. Patients who are totally paralyzed can be given these implants, which allow them to control a computer mouse for spelling out messages, playing games, or surfing the web. For someone who is otherwise locked in an unresponsive body, these implants can radically improve quality of life.

Research into neuroprosthetics is an ongoing and cutting-edge area of science. We should expect to see many more developments in the future, some of which will challenge common assumptions about the interface between the mind and machines.





A baby aspirin-size brain sensor containing 100 electrodes, each thinner than a human hair, that connects to the surface of the motor cortex (the part of the brain that enables voluntary movement), registers electrical signals from nearby neurons, and transmits them through gold wires to a set of computers, processors and monitors. The goal is for patients with brain stem stroke, ALS, and spinal cord injuries to eventually be able to control prosthetic limbs directly from their brains.



An earlier version of the BrainGate system helped a young tetraplegic named [Matt Nagle](#) control a mouse cursor and operate a very basic prosthetic hand.

Brain implants may allow paralyzed people and amputees to use mind-controlled advanced prosthetics sooner than we think, with a very specific kind of "telekinesis" aided by a wireless brain-computer interface. The National Institutes of Health has announced that a compact sensor has successfully recorded and transmitted brain activity data wirelessly in an animal trial for over one year.

The brain implant is a huge step towards wireless devices that can control advanced prosthetics, and will allow much more natural studies of brain activity in moving research subjects.

Researcher controls colleague's motions in 1st human brain-to-brain interface

University of Washington researchers have performed what they believe is the first noninvasive human-to-human brain interface, with one researcher able to send a brain signal via the Internet to control the hand motions of a fellow researcher.

Using electrical brain recordings and a form of magnetic stimulation, Rajesh Rao sent a brain signal to Andrea Stocco on the other side of the UW campus, causing Stocco's finger to move on a keyboard.

While researchers at Duke University have demonstrated brain-to-brain communication between two rats, and Harvard researchers have demonstrated it between a human and a rat, Rao and Stocco believe this is the first demonstration of human-to-human brain interfacing.

"The Internet was a way to connect computers, and now it can be a way to connect brains," Stocco said. "We want to take the knowledge of a brain and transmit it directly from brain to brain."



Patents for technology to read people's minds hugely increasing

Fewer than 400 neuro-technology related patents were filed between 2000-2009. But in 2010 alone that reached 800, and last year 1,600 were filed, according to research company SharpBrains.

The patents are for a range of uses, not just for the healthcare technology that might be expected. The company with the most patents is market research firm Nielsen, which has 100. Microsoft also has 89 related patents.

Other uses of the technology that have been patented include devices that can change the thoughts or feelings of those that they are used on.

But there are still medical uses — some of those patents awarded include technology to measure brain lesions and improve vision.

Scientists Can Pluck Images Out Of Your Dreams

A new method can visualize with 60 percent accuracy what you're seeing while you sleep.

With just an fMRI, an algorithm, and the internet, researchers from Kyoto, Japan predicted with 60 percent accuracy what a person was dreaming about, [Smithsonian magazine reports](#). The idea, like the process, isn't all that complicated: Our brains react measurably differently to different stimuli: looking at a book or a building doesn't cause the same reaction. So the Kyoto team had three people sleep in an fMRI for three-hour stints over 10 days, and hooked them up to an EEG, which used electrical signals from the body to track which stage of sleep the were in.

Early on, just a few minutes after falling asleep, dreams started coming in bursts. The scientists woke the subjects up soon after and asked them what they saw. (For each participant, they actually did that 200 times, presumably turning them into the Grumpiest People In The Universe.) The researchers wrote down the 20 most common things the subjects saw: people, buildings, etc. They then found images on the internet that matched those common things, showed them to the subjects while they were awake but still in the fMRI, and took a reading. That information was fed into a learning algorithm. When the subjects slept again, the algorithm spit back this '80s music video-like representation of what the sleepers saw.

RESEARCHERS CREATE SHORT-TERM MEMORIES IN-VITRO

Ben W. Strowbridge, PhD, Professor of Neurosciences and Physiology/Biophysics, and Robert A. Hyde, a fourth year MD/PhD student in the neurosciences graduate program at Case Western Reserve University School of Medicine, have discovered how to store diverse forms of artificial short-term memories in isolated brain tissue.

"This is the first time anyone has found a way to store information over seconds about both temporal sequences and stimulus patterns directly in brain tissue," says Dr. Strowbridge. "This paves the way for future research to identify the specific brain circuits that allow us to form short-term memories."

Their study, entitled "Mnemonic Representations of Transient Stimuli and Temporal Sequences in Rodent Hippocampus In Vitro," is slated for publication in the October issue of *Nature Neuroscience*, and is currently available online.

The non-public government perfected the synthetic telepathy technology a long time ago. 





MIT scientists implant a false memory into a mouse's brain

Sometime soon, a lab mouse could wake up thinking he had snuggled up to a girl mouse the night before. But he hadn't. The memory would be fake.

Scientists have successfully implanted a false memory into a mouse's brain — a seemingly far-fetched idea reminiscent of a science fiction film.

"If mice had Hollywood, this would be 'Inception' for them," said one of the lead researchers, MIT neuroscientist Steve Ramirez, whose study was published online Thursday in the journal Science.

Ramirez and his colleagues tagged brain cells associated with a specific memory and then tweaked that memory to make the mouse believe something had happened when it hadn't.

Although implanting a memory won't happen anytime soon in people, in principle, it should be possible to isolate a human memory and activate it at will, scientists said.

"We would have every reason to expect this would happen in humans exactly as it happened in mice," said Michael J. Kahana, who was not involved in the study but is director of the University of Pennsylvania's Computational Memory Lab.

Disinformation in the Form of Legal Mythology

- False legal theories designed to confuse and stumble pro-liberty individuals
 - Objectives:
 - Divert them from self-educating about legitimate and relevant legal issues

- Discredit legitimate methods of asserting rights, by association with frivolous arguments
- Portray pro-liberty citizen activists as dangerous "extremists" and/or mentally unstable

- As George Washington observed, "government is not reason, it is not eloquence, it is force. Like fire, it is a dangerous servant and a fearful master." Both levels of sovereignty in the American system - the states and the federal government - are capable of infringing on liberty.





Read your mind? Not in a 'million light years'

The members of the Presidential Commission for the Study of Bioethical Issues received a primer today on recent advances in the use of medical technology on neuro-imagery. It was a session that Dr. Gregory House of the TV show *House* would have found fascinating – especially the multiple uses of MRI machines to help detect hard-to-diagnosis diseases.

The Commission is considering whether to embark on examining ethical issues surrounding the uses of neuro-imagery and genetic testing.

A panel of scientists said that one cutting-edge ethical issue now involves how private companies could use this technology for what they called "neuro-marketing" in order to advance the sale of products.

But one issue not on the table: whether new technology can help read minds – because it can't.

Such technology "is a million light years away," said Dr. Martha Farah, the Walter H. Annenberg Professor in Natural Science and Director of the Center for Cognitive Neuroscience at the University of Pennsylvania.

Science isn't close to enabling researchers to read the thoughts of others, Farah said in an interview. Still, though, she knows people fear that it will happen. She said she gets asked about it frequently.

"We are nowhere near being able to read sentences or thoughts that are the equivalent of sentences," Farah said. "But it is the case that we can derive a fair amount of personal information including current mental states, such as mood, intentions, and desire to buy an object" from Functional MRIs, or fMRIs.

But the interpretation of brain imagery, captured in fMRIs, was far from perfect, she said. "There is a lot of significant personal information from fMRIs. It is with a degree of accuracy that is far from perfect, but is well above chance."

That leads Farah to be wary of neuro-marketing. "The biggest ethical issue to me is the fact that







Synchronicity, Quantum Information and the Psyche

Abstract

In this paper we describe synchronicity phenomena. As an explanation of these phenomena we propose quantum entanglement between the psychic realm known as the "unconscious" and also the classical illusion of the collapse of the wave-function. Then, taking the theory of quantum information as a model we consider the human unconscious, pre-consciousness and consciousness as sets of quantum bits (qu-bits). We analyze how there can be communication between these various qu-bit sets. In doing this we are inspired by the theory of nuclear magnetic resonance. In this manner we build quantum processes that permit consciousness to "read" the unconscious and vice-versa. The most elementary interaction, e.g. between a pre-consciousness qu-bit and a consciousness one, allows us to predict the time evolution of the pre-consciousness + consciousness system in which pre-consciousness and consciousness are quantum entangled. This time evolution exhibits Rabi oscillations that we name mental Rabi oscillations. This time evolution shows how, for example, the unconscious can influence consciousness and vice-versa. In a process like mourning the influence of the unconscious on consciousness, as the influence of consciousness on the unconscious, are in agreement with what is observed in psychiatry.


1 Synchronicity Effects


Synchronicity phenomena are characterized by a significant coincidence which appears between a (subjective) mental state and an event occurring in the (objective) external world. The notion was introduced by the Swiss psychoanalyst Carl Gustav Jung and further studied together with Wolfgang Pauli (Jung and Pauli, 1955). Jung referred to this phenomenon as "acausal parallelism" which are linked by an "acausal connecting principle." Synchronicity effects show no causal link between the two events that are correlated.

Mind Control 302: Brain Implant Bloopers



There have been numerous news items over the last few years about major television news reporters suddenly beginning to speak

in complete gibberish during live television presentations. The writers of these stories always think that something very strange and mysterious is going on, and speculate as to what that might be. Did the reporter have a stroke on air? Were they being hit by secret microwaves?

There is a simple black-and-white answer. As I have documented elsewhere in [this series](#), state security services have been covertly implanting citizens with classified "synthetic telepathy" neurotechnology. My research indicates that the technology was perfected no later than the mid 1960s, and possibly by the 1940s.

A significant portion of the civilian population ALREADY has government implants in their brains which allows remote control of the mind (verbal thoughts, perceived images and sounds, nightly dreams, motor commands). I don't know the exact numbers, but I have reason to believe that young children in average families have been implanted, so it logically follows that people in positions of public influence like these news reporters would almost certainly be "owned" in this very physical way. The only thing I'm not really sure about is whether these incidents were caused by malfunctions in the neurotechnology, or were deliberately instigated by the remote operators.



I used to have individual videos published of each instance of the reporters having on-air meltdowns, but all of these events have now been included in a compilation video, so I am posting that here instead. The most interesting thing about this compilation is that whoever edited it together added some text to the very beginning of the video: "This could be the early steps of humanity evolving into something else in 2012." Spiritual evolution and 2012

mythology are both extremely common disinformation themes, as I have previously documented (see [MC301](#)).

This tells me that the compilation video was probably put together in an attempt at damage control. Since the story involved television broadcasts that had already been viewed and possibly recorded by millions of people, it could not be simply erased from history. So a version of the story was deliberately put out with the disinformation text added at the very beginning to throw viewers off track.

Interestingly, the video concludes with an example of this happening to radio co-host Ian Punnett of *Coast to Coast AM*. *Coast* is a widely-syndicated late night talk radio program in the United States which heavily promotes disinformation topics. Host George Noory introduces the segment in question by saying "next hour, [...] we talk about one of Ian Punnett's favorite subjects, cryptozoology." I think it is quite telling that a journalist associated with this particular type of program subsequently became a victim of the technology himself.

Aaron Alexis Mental Health: Gunman In Navy Yard Shooting Heard Voices

WASHINGTON — A month before he went on the rampage that left 13 dead, Washington Navy Yard gunman Aaron Alexis complained to police in Rhode Island that people were talking to him through the walls and ceilings of his hotel rooms and sending microwave vibrations into his body to deprive him of sleep. **This is MKULTRA, folks. No question.**

The account, contained in an Aug. 7 report from Newport, R.I., police, adds to the picture that has emerged of an agitated and erratic figure whose behavior and mental state had repeatedly come to authorities' attention but didn't seem to affect his security clearance.

Alexis, a 34-year-old information technology employee at a defense-related computer company, used a valid pass Monday to get into the Navy Yard and killed 12 people before he was slain by police in a shootout that lasted more than a half-hour.

A day after the assault, the motive was still a mystery. U.S. law enforcement officials told The Associated Press that investigators had found no manifesto or other writings suggesting a political or religious motivation.

"Treatment" as an MKULTRA subject, that is. Alexis, a former Navy reservist, had been undergoing mental health treatment from Veterans Affairs since August but was not stripped of his security clearance, according to the law enforcement officials, who spoke on condition of anonymity because the criminal investigation was still going on.




Capitol Suspect Miriam Carey Believed Obama Electronically Monitored Her

The woman who led police on a high-speed chase near the U.S. Capitol before being shot dead had a history of mental illness and believed President Obama was electronically monitoring her Connecticut home in order to broadcast her life on television, sources said.

Sources told ABC News that Connecticut police had twice in 2012 been called by Miriam Carey's boyfriend, who reported the woman was delusional, acting irrationally and putting her infant daughter in danger.

Carey, 34, a dental hygienist from Stamford, Conn., was killed by police Thursday after trying to ram a White House gate and leading cops on a chase down Pennsylvania Avenue with her 1-year-old daughter in the car. The toddler was uninjured and placed in police custody.

According to sources Carey believed she was the "prophet of Stamford" and was capable of communicating with Obama.

This symptom indicates that Carey was likely being abused by "synthetic telepathy" neurotechnology. See MC101.

Her mother, Idella Carrey, told ABC News that her daughter had been hospitalized after suffering post-partum depression.

On Dec. 10, 2012, police were called to Carey's home by her boyfriend Eric Francis, 54, father of

her baby. Francis told police Carey was emotionally disturbed and he believed his daughter was in danger, according to sources.

Carey told police President Obama had placed Stamford on lockdown and had arranged to have her home electronically monitored and her life broadcast on television, sources said.

Tamerlan Tsarnaev, the 26-year-old suspected Boston Marathon bomber, was haunted by voices and feared that someone was gaining control over his mind prior to the devastating attack, according to a new report by The Boston Globe.

Tamerlan's younger brother, Dzhokhar, 20, is also accused of carrying out the April 15 bombing, which killed three and injured more than 260. Though Tamerlan died during a shootout with police days after the incident, Dzhokhar was apprehended and faces the death penalty if convicted.

After a five-month investigation into the suspected bombers' backgrounds, the Globe has published a lengthy piece that paints a startling portrait of the dysfunctional Tsarnaev family. Drawing from reporting in the U.S., Kyrgyzstan, Russia and Canada, the Globe claims that the motivation behind the bombing was "more likely rooted in the turbulent collapse of their family and their escalating personal and collective failures" than in what federal investigators suspect to be a jihadist agenda.

The report points to warning signs that Tamerlan was suffering from mental illness and "had some form of schizophrenia," a family friend told the newspaper.

"He [Tamerlan] had told his mother that he felt there were two people living inside of him," Anna Nikaeva, another family friend, told the Globe. "I told her, 'You should get that checked out.' But she just said, 'No, he's fine.'"

According to an interview with Tamerlan's close friend, Don Larking, whom he met at his local mosque, Tamerlan was worried that uncontrollable voices in his head were directing him to do something he didn't want to do.

"He believed in majestic mind control, which is a way of breaking down a person and creating an alternative personality with which they must coexist," Larking told the Globe. "You can give a signal, a phrase or a gesture, and bring out the alternate personality and make them do things. Tamerlan thought someone might have done that to him."

AURORA, Colo. — The suspect in the Colorado theater rampage was seeing a University of Colorado psychiatrist who studies schizophrenia, according to court records released Friday, indicating for the first time that university officials were familiar with James Holmes's mental state.

Holmes was a patient of Lynne Fenton, the medical director of student mental health services at the university, according to the suspect's lawyers. Holmes withdrew from a PhD program in neuroscience after taking oral exams in early June.

Police say that Holmes carried out a methodically planned assault on moviegoers in a sold-out theater, employing legally purchased guns that he began acquiring in May. Twelve people died in the attack, and 58 were injured.

Santiago had been treated for mental health issues in Anchorage, where he lived, officials said. His aunt told NBC News that the former National Guardsman was "not OK" after returning from a 10-month deployment in Iraq.



Weier, now 15, pleaded guilty to attempted second-degree intentional homicide

in a deal with prosecutors in August. But she claimed she was mentally ill during the attack and not responsible for her actions, in a bid to be sent to a mental institution rather than prison. A plea agreement called for her to spend at least three years in a mental hospital if judged mentally ill, and 10 years in prison if not.



It seems like lately, if there is a mass shooting incident being publicized by the mainstream media, one can pretty safely assume that the shooter was a CIA mind control subject. In just about every case lately, there exists some major red flag that the "mental health" issues being suffered by these shooters is really a symptom of CIA mind control. NASHVILLE, Tenn. — The suspect in Sunday's killings at a Tennessee Waffle House once lived in Colorado, where police say a co-worker described him as being paranoid and delusional at times. The co-worker also told a detective the man was infatuated with Taylor Swift and claimed to be a sovereign citizen.

Travis Reinking lived in Salida, Colorado, for several months in 2016 and 2017 and worked at a company called Rocky Mountain Crane, Detective Sgt. Rob Martellaro of the Salida Police Department said in a report Monday.

One of Reinking's former co-workers told Martellaro that Reinking had identified himself as an anti-government "sovereign citizen" who also disliked the National Rifle Association. The FBI says sovereign citizens believe they are separate from the U.S. and don't have to answer to any government authority, including courts and law enforcement.

Martellaro said the former co-worker left him with the impression that Reinking's interest in the sovereign citizen movement was part of his "delusional makeup."





Particular kinds of automobiles: white vans/trucks; red autos; police cars.





In these campaigns, operatives [masquerading as victims](#) publish websites and participate on internet discussion forums. In more than one instance, they have solicited monetary donations from actual victims for the claimed purpose of purchasing expensive equipment to figure out what "frequencies" are being "beamed" at them. The primary purpose is not to collect money as such (although depriving targeted individuals of financial resources is certainly a related goal) but rather in this instance to **frame the very issue of targeting itself** in terms of "directed energy weapons" abuses -- which is a smokescreen.

Directed-energy weapons are a fact of modern military and law-enforcement technology and without a doubt are subject to abuse by authorities. However, **spending money on frequency counting equipment is probably not going to help you if what you are actually dealing with is advanced classified neurotechnology in your brain.** The solution to brain implants would be removal or disabling of the device. Trying to "block the frequency" as such would probably be an exercise in futility.

For example, modern GSM cellular networks use advanced frequency-hopping algorithms where the frequency of the transmission changes several hundred times per second according to a pre-determined mathematical formula. Whatever type of wireless network is being used to control the brain implants is probably also using some type of extremely advanced frequency hopping and/or spread-spectrum technologies. A spread-spectrum transmission offers three main advantages over a fixed-frequency transmission:

1. Spread-spectrum signals are highly resistant to narrowband interference. The process of re-collecting a spread signal spreads out the interfering signal, causing it to recede into the background.
2. Spread-spectrum signals are difficult to intercept. An FHSS signal simply appears as an increase in the background noise to a narrowband receiver. An eavesdropper would only be able to intercept the transmission if the pseudorandom sequence was known.

[Response from Jeff]

If you mean remote mind control via implant versus without implant, then I am not actually sure. My best answer would be to say that I agree with Jeremy's appraisal of the situation at the Bioethics hearings, which I have pasted below for your review.

I'm not familiar with any devices that can detect/decode "modulation content" of a transmission that is digitally encrypted and/or using frequency hopping spread spectrum types of technologies.

You can go to Radio Shack and buy a Bearcat scanner that can pick up the narrow FM carrier frequencies used by a lot of police, fire, ham radio etc. Those are unencrypted analog signals. Some of the newer equipment might also be able to decode some digitally modulated signals, I'm not really sure.

But take your modern cell phone on a GSM network, which is one thing I know a bit about. The "modulation content" as you describe it (your spoken voice) is going to be digitally compressed (like an MP3 music file) then encrypted for privacy, all in the phone in real-time, then that encrypted digital signal goes out through the antenna over the airwaves, changing frequency over 200 times per second. That technology was put into commercial use in the 1990s. As advanced as it sounds, IT'S OLD NEWS.

I can't imagine that anyone would be foolish enough to do as he suggests, but perhaps there are a few desperate people out there who don't understand what is going on here and might get drawn into something like this. 


