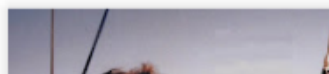

Willem Holleeder has already invested a sloppy 150 million at Dijkhuis and Paarlberg. Now Willem Holleeder's girlfriend is supposedly a daughter of Chris Dijkhuis, so such an investment should not be surprising.

The Dijkhuis real estate management owns the Rembrandt Tower on the Amstel, as well as the Hilton Hotel chain and is busy investing in the construction of the New Waldorf Astoria Hotel. (We will come back to who and what Dijkhuis real estate is)

At the time of Bruinsma and before the IRT affair of Maarten van Traa it is known that Karel Vosseveld (Stanley Karel Esser) transported hundreds of millions worth of drugs, whereby the import of these drug containers was arranged by, among others, the FIOD man Cees Janssen. 4 and 6 months in prison, for amounts received and perjury. Cees Janssen was so ill and almost dead during the IRT affair and could therefore not appear before Traa's committee, so that his bribes were never substantively investigated. Strangely enough, the next day the same Cees could be seen alive and kicking again in one of his sports institutes, teaching like a young deer. Fred Teeven was also unable to make any meaningful statement about the bribe, but he did exchange information with Robert Mink Kok. Fred Teeven's career has skyrocketed since then

It should still be visible anyway. Around 1985, André Brilleman arranged an appointment for a meeting with Klaas Bruinsma

for 4 up-and-coming young criminals (**the Van Korlaar family, Evert, Kees, Peter and Adelbert**) . The 4 had set up a full-fledged import and export line in and through the Netherlands. To this end, they had at their disposal a complete fleet of seaworthy sailing yachts for picking up coke off the coast of South America, as well as a fleet of hotel ships with their home port of Arnhem for transporting the coke throughout Europe.



The family had recruited their own suppliers in Colombia, in particular the twin brothers Miguel Angel and Victor Manuel Mejia Munera, who were fully raised by the Van Korlaar family from the age of 18 .

Bruinsma clearly showed that he tolerated no interference and the four were **mistreated and severely humiliated**kicked out, with the youngest and smallest of the bunch (later nicknamed

Tweespaltmaker), coming out more dead than alive. These 4 brothers of Korlaar, (with later nicknames the Allesweter, the Commissioner, the Tweespaltmaker and the 4th Nitwit) swore revenge. When De Tweespaltmaker had finally progressed to the point that he could be lifted out of bed and put in the front of the car, an appointment was made with André Brilleman in February 1985 to discuss it again.

André Brilleman was asked to come to Den Bosch on Sunday morning for an appointment with the brothers at the parents of the "Allesweter" in the Gelderland residence. Brilleman came by train and was picked up from Den Bosch station. The Allesweter was behind the wheel and the Tweespaltmaker had still not recovered and lifted into the co-driver's seat. The car drove the 5 people over the Zaltbommelse bridge to a plot in the floodplains west of that bridge. On that plot, the 4 had prepared a red petrol barrel and material for making concrete. Brilleman was tied up and gagged and after a

On that plot, the 4 had prepared a red petrol barrel and material for making concrete. Brilleman was tied up and gagged and after a bottom of concrete (pure cement) had been poured into the barrel, Brilleman was placed with his feet in the barrel after being worked on by two burly brothers. Brilleman was held until the concrete had hardened reasonably. A chair was taken from the trunk of the car and placed in front of Brilleman. Then De Tweespaltmaker was lifted out of the car and put in the chair to finish it with bullets. The barrel filled up and hardened was deposited with the body of Brilleman in the Waal. There are still four men left for them to take their revenge on, but for practical and tactical reasons they postponed their revenge until later. Because of that delay, Klaas Bruinsma was liquidated by someone other than these upcoming criminals. (June 27, 1991)

When these 4 criminals thought it was time for liquidation, they liquidated the remaining ones on almost the same day. De Allesweter has taken care of John Mieremet (November 2, 2005). The Commissioner and De Tweespaltmaker have taken on behalf of Kees Houtman and also Evert Hingst. (November 2, 2005 and October 31, 2005) Hingst (lawyer, Evert Drijber) and Hillis had a real estate company in Ibiza. The security cameras of Stanley Hillis, Hingst's neighbor, captured Hingst's liquidation. Hillis handed over the images to the criminal investigation department, but the images were never shown and Peter la Serpe was offered to the OM, so that the OM would not reach the brothers. Hillis, who knew too much, was liquidated in February 2011, **we will come back to this**)

De Allesweter had already made contact with the Italian mafia, Ndrangheta, and offered his services there, with clear disclosure of what they had achieved in the criminal field of drug trafficking and what channels they had for laundering the gigantic criminal profits. The Ndrangheta saw something in that Dutchman and he (and with it the other 3 of the family) were accepted in their midst. Because the members of the Ndrangheta are often trained from childhood in the criminal trade and walk, it seemed better to the Ndrangheta top that De Allesweter first apprenticed with them for a few years. That took 3 years during which De Allesweter was included in the learning process of the Italian mafia between his official activities in society. Because the song "Kedengkedeng" by Guus Meeuwis echoed from Cor van Hout's car radio, Peter, who is a music teacher, was somewhat taken aback by this. The liquidation failed. The problem, however, was that this was recorded on security camera, but was never shown to van Hout.

A performance of almost 30 minutes of atrocities. Those beatings end when one criminal pulls out a long iron pipe with a point. Then the biggest criminal lifts the victim by the waist and impales the victim on that iron pipe.

The criminal holding the pipe holds it up for at least a few more minutes and the victim can be seen convulsing and dying. Then the criminal drops the pipe with the victim still attached to the floor with a bang. End of the performance.

The above-mentioned top criminals discovered that there was an equally high demand for Satanic murders in the noble circles and related groups so that beasts like Dutroux could develop unlimitedly due to them. They had made themselves popular as suppliers via the Cercle Lorraine in Brussels in a club of Belgian nobility who were routinely involved in hunting children. That hunt just took place during the day, at the place Oudergem in Belgium. The parking lot and the entire forest are cordoned off with construction fences and the entrance is tightly guarded by guards from the royal guard. The hunters let the eldest boy go halfway into the clearing and then he was shot in the back. His genitals were also removed by a group of three hunters.

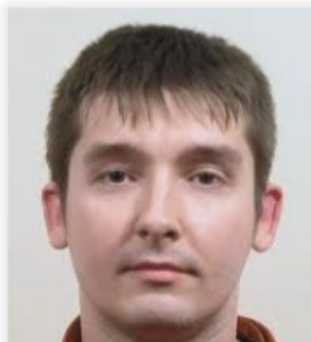
One of the hunters held it in the air with a cry of joy. This ended the hunt.

The K. family arranged for Robert Mikelsons to come to the Netherlands from Germany. Mikelsons has been charged with his pedophilia and pedophile history in Germany. 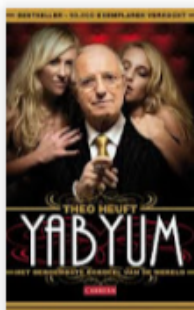

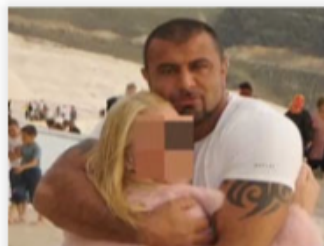

A helicopter filmed the entire operation from the air, so the murder is on tape, but due to aviation restrictions (?) the helicopter must stop the pursuit, according to the official statement. Nonsense, because flying above a residential area lower than a flight height of 300 meters AGL (above the ground), is prohibited for (other) aircraft. The true situation is therefore different. It was known that Hillis had consulted with the police and allowed an eavesdropping situation. The van was of course never found, for the reason that it was loaded onto an inland vessel that same evening and probably sunk in the IJsselmeer. The van was stolen six months before the murder, but the detective says that on September 5, 2010 (five months before the murder) the van was photographed in North Amsterdam and that there is also a photo of the driver, the suspected perpetrator. Where is that photo? Robert Mink Kok is in possession of very compromising photo and film material on which members of the "Royal" House, Judges, senior officials of various Ministries and Justice can be seen. Greg Remmers grew up in Ned. Indies and is seen by the judiciary as one of the leaders in the Amsterdam drug environment. His organization is in close contact with the notorious Colombian Cali cartel. An important role within the organization has been reserved for his sons, who each hold key positions within the Remmers group. At the end of 1997, the detectives under the code name 'Speed' started a large-scale investigation into Remmers' gang. They discovered that the Amsterdammer had close ties with the Colombian drug lord Eugenio 'Don Hugo' Montoya. On December 14, 2000,

Remmers was finally convicted of drug trafficking and given a seven-year prison sentence. Andy Remmers was sentenced to five years in prison, and his brother Danny was acquitted. After Ros was arrested in January 2003 for possession of weapons, the house in Vinkeveen was searched. There the police found a veritable arsenal of weapons.

Greg Remmers and two of his sons were arrested in January 2004 on suspicion of involvement in this collection of weapons. Shortly after the murder of Van Houden, a large batch of weapons was found by the police in a villa in Vinkeveen. The villa was rented by Fred Ros, who had been arrested three days earlier for carrying a weapon. In addition to Ros, Jesse Remmers must also answer for the load of weapons. Together they are in custody for a long time. After his release in 2003, G. Remmers had not been idle for long. He almost immediately went back to dealing in drugs and weapons. In May 2003, for example, he got into a conflict over a shipment of amphetamine. Greg Remmers would supply that to two Yugoslavs, Serjan M. and Alexander Bulatovic. They would sell it to British drug trafficker Peter G. However, the deal failed because the speed was said to be of poor quality. Remmers himself is arrested on June 3, 2003. Another son, 1968-born Jesse Remmers and hitman, was arrested in February 2007 in connection with the murder of Thomas van der Bijl. In November 2011, Greg Remmers is sentenced to 24 years in prison in Naples, Italy, for his involvement in an international drug gang. Remmers has been imprisoned for this Italian case since June 2010. Greg Remmers claims to be innocent. In the same opinion of the top Italian lawyers of Greg Remmers, Ettore Stravino and Carlo de Pascale, there is also no substantial evidence against their Dutch client in the already available Italian files of the Tamanaco case. The Tamanaco case involves preparatory acts in 2004 and a major drug bust by the Italian police in 2005. However, Greg Remmers was detained from April 1999 to June 2006, making it impossible for him to play a significant role in this.

On the occasion of her 80th birthday, writer Yvonne Keuls was interviewed by EenVandaag. Among other things about her book 'Annie Berber and the grief of a tender criminal'. In it she describes how a judge in The Hague (Rueb) assaulted boys. In EenVandaag, Keuls is furious about 'the godforsaken arrogance' within the court in The Hague and about 'the cowardice of politicians and the judiciary'.
