At the top of the various divisions (led by families) is the "Don" (Lord Ndrangheta). They are assisted by consiglieri (counsellors, usually in the form of blackmailed judiciary and/or ditto lawyers). The Don gives

orders to his captain of a regiment. A regiment is again subdivided into different teams, working in 4 segments, as mentioned. These teams are in turn controlled by what we will call a sergeant who has the executive actions carried out by his soldiers.

In "Part 1" a corner of the veil has been lifted from this secret organization. As explained on this site, the criminal organization has succeeded in infiltrating the most sensitive places in the Dutch constitutional state through bribes and blackmail. Once in possession of collected sensitive data, it is easy to permanently blackmail individual characters and even an entire kingdom. However, in order to maintain this for a long time, the pressure must remain on the boiler and the infiltration must take place up to the highest top. The organizational talent used here can be called brilliant, were it not for the fact that we are talking about a criminal organization that undermines the rule of law, which offers a reprehensible opportunity to the most perverse preferences of the blackmailed persons to renew the blackmail means. The discrediting is predominantly one person at a time, never groups. With the help of the media (for example Peter R. de Vries) it is possible to accuse a single individual, whether or not justly, and to bring him into serious embarrassment. The characters are never tackled simultaneously and/or in a group. Just pay attention to that.

4. **The age of the board members in the trade register history can be called remarkably high (around 70 years) and gives the impression that they were only chosen for form.**  
(You can't find that at TBI!)

**Initially, this abbreviation TBI was thought to stand for "Ter Better Investment" but this choice was found too striking by the criminals and the abbreviation TBI stood for: Engineering Construction and Industry.** Former OGEM director "Lense Koopmans" was chosen as director of this company. On Sunday afternoon, August 17, 1980, the Ogem top signed more than a thousand documents, each statement in 24-fold. "I had to refill my pen several times," Koopmans later said to the curators H. Ophof and D. Slager.

Koopmans therefore continued as director of the construction and installation companies that "executed" from Ogem in the event of bankruptcy as TBI Holdings.

TBI is a network of companies active in the real estate, construction and technology sectors. **An opportunity to make price agreements and to make construction fraud completely obscure.** Koopmans has avoided media and photographers ever since, although, especially after his departure from TBI (1994), he is one of the most sought-after switch guards at the point where business and government meet. Certainly not of an undiscussed amount (IRT affair), but exactly the person who fits in the criminal alley.

**His successor Rinus Platschorre, the husband of Carla Peijs, was striking.**

Carla Peijs is the Queen's Commissioner in Zeeland and now Vlissingen is one of the ports that the criminals use for their drug transports.

The network construction and interconnectedness of TBI is immense and large.

Former BVD employee arrested

The National Criminal Investigation Department has arrested a suspect who allegedly violated state secrets. He is a former employee of the BVD, the predecessor of the AIVD. The AIVD traced him through an investigation that was set up in response to an article in De Telegraaf. The newspaper wrote in January that BVD secrets had ended up with top criminals such as Mink K. in the 1990s. Top officials from the judiciary and police allegedly helped K. for money, including by leaking information. The AIVD investigation has therefore led to a former employee who was arrested today.

This concerns Paul Herrie alias Sentaro? He was already sentenced to two years in prison in 2007, as we get from the reporting of the ANP on 22-10-2007:

The court in The Hague today sentenced former BVD member Paul H. to two years in prison. H. is sentenced for taking state secret documents about an investigation into a group of 'top criminal' Mink K.

The court acquitted H. of leaking information; it does not consider it proven that he sold the information from the former intelligence service to K.. The court acquitted two co-defendants in full. Justice suspected them of stealing H.'s sensitive information and passing it on to De Telegraaf newspaper.

The case came to light after a publication in De Telegraaf in January last year. This contained information from the BVD investigation into K. The newspaper reported, based on the documents, among other things, that K.'s group reserved millions for bribing police and judicial personnel.

With the money, Mink K. bought police files, among other things. Liquidations were also allegedly carried out with weapons seized by the police, which were 'lent' for the occasion. However, no hard evidence for this corruption was ever brought to the table.

H. denies that he gave the secret BVD information to Mink K.. The ex-employee of the BVD says that he was tricked by the two co-suspects. They say they blamed him for the leak, out of spite because of a business dispute. Paul H. had a considerable debt to one of the two co-defendants.

NOTE: Paul H. is also said to have written the so-called Barbertje and Miranda letters to Mink Kok. However, the information is that the correspondence took place between Mink Kok and the Allesweter, which were then analyzed by the Commissioner and typed out a return letter in similarly coded style on the typewriter. After all, De Allesweter was aware of all legal information through his bribed and blackmailable contacts at the highest judicial level.

### The Baja Beach club in Rotterdam



This club, where Kees van Korlaar also acted as a clown, also offered the opportunity to give assignments to criminals. The entire police forces seemed to (want to) understand nothing about why all Amsterdam criminals liked to go out to the Baja Beach Club in Rotterdam.

At the entrance, the invited criminals were provided with **colored earplugs** in different colors and **different frequencies**.

Evert van Korlaar, the Omniscent, sitting invisibly in a back room with a video overview of the entire club, could thus order a liquidation, for example. Kees van Korlaar, dressed as a Clown, checked how the assignment was received by that particular criminal. With verbal acceptance, a cash deposit was delivered to the acceptor the following day.

After a successful completed assignment, the rest of the money was delivered.

### The Lange van Bergen family.



The de Lange family are in fact the descendants of an 18th century thief and swindler named Pieter Pergerrits.(born 1707 in Oostzaan) De Lange van Bergen even devoted a website to this man.

Because that Pieter Pergerrits was a notorious thief, he had to leave the Netherlands in a hurry, leaving his wife and children behind. He disappears to Denmark and changes his name to Pieter van Bergen. Later in Pieter de Lange van Bergen. Because of the disgrace, his wife and children then adopted the woman's surname, De Lange. Pieter Pergerrits has ensured that the assets he stole from Denmark were slowly returned to his children

De Lange in Amsterdam. In 1997, however, the old Dutch **nobility was strongly resented** because then the Danish title of the De Lange van Bergen family was recognized in our country. And this family owes their title to the master con artist Pieter Pergerrits who in 1749 buys an estate in Denmark with stolen money and with it a title of nobility. The father of the Haarlem Notary mentioned above and known to us by name was also a descendant of the De Lange family, who can now call themselves the esquires De Lange van Bergen, thanks to Beatrix van Amsberg.

Evert van Korlaar and the De Lange van Bergen family have known each other since the early 1980s.

Notary AH introduced the Van Korlaar brothers to the Stuyling de Lange family (descendants of Pieter Pergerrits) and active in the Merger and Acquisition industry. The brothers are present at the 2 annual meetings at which the investments of the family assets are discussed, as well as the criminal results of the Van Korlaar brothers. The De Lange van Bergen family includes various judges, lawyers, members of the Public Prosecution Service and professors. This family must therefore be fully aware of the actions of the Van Korlaar brothers.



The murdered kidnapped women and young girls were buried **by the brothers in 4 known places** . In 2000, these places **were reported to the police and the judiciary** , but no investigation was ever done. However, at 1 designated location below, a shovel has performed "work" for weeks , which has been observed.

ONE of those places is a country house in W. on the G. road. The huge well belonging to this estate, as well as the vegetable garden, have been used as a cemetery for liquidated persons. The manager of this estate received 10,000 each time the brothers wished to use the well and/or vegetable garden. The Estate has been for sale for a long time, but the "usufruct" is officially still in the name of MJ Stuyling De Lange-Fenenga.

She had hitchhiked from Austria and her blonde hair shown in Austria had changed to her original auburn color. K.'s parents and brothers received the girl "hospitably". During dinner in Hoenzadriel, the brothers of "Mister K" suggested to that Austrian girl that she should stay there that night, but that the brothers would take her back to her Austrian parents the next day. The next morning, the brothers drove north with that girl in the backseat between them. After they had driven into a forest plot, this girl was raped and strangled according to ? She was, according to information, completely undressed and thrown into a shallow ditch like old dirt, discarded!

A body was found within 2 weeks of this. On October 24, 1976, a forester who walked the dog with his wife found a body in the parking lot De Heul along the A12 near Maasbergen. This **Franz Kroell was also the police chief** who handled the Natascha Kampusch case. After contact, this police chief committed suicide, according to the Austrian media. We venture to doubt this. Jair Soares (disappeared August 4, 1995) The 7-year-old was kidnapped by K. van K. and held captive in the Sara Catharina mill in Hoenzadriel, abused daily and brutally murdered.

Tanja Groen (September 1, 1993) was also kidnapped by them and held captive in the upstairs room of the Mill in Hoenzadriel. (Upstairs room: a connecting room between the house and the Mill) (An eyewitness confirms this detention) The daily rape and every 2 days of taking cerebrospinal fluid she had to let go for almost 1 year in captivity, before she was liquidated and buried under the duckweed tree in the orchard behind the mill.



The prisoners were provided with food by Sjan van Korlaar and the hair was taken care of by Inneke van K.



According to eyewitnesses, 19-year-old Germa van den Boom (disappeared in 1984) was also transported to the mill, raped and liquidated to be buried elsewhere. Reporting the murder of Germa van den Boom to the police has, as expected, led to nothing. Only the meaningless e-mail answer was returned to the report, after which nothing was ever heard from again:

Thank you for your quick (re)action by sending the information regarding the missing Germa van den Boom.

The information has been forwarded to the criminal investigation department, which is investigating the case (as I already told you, I do not conduct any investigations into this myself).

The research team has confirmed receipt of the information and will assess its added value over and above the information they already had.

With regard to the Biesbosch location/house; this information was passed on to the Altena team detective.

Found December 25, 1990.

This unidentified victim had many burns on her body from lit cigarettes put out on her. She was found in Teteringen.

She showed signs of having been gagged.

The pathologist noticed that she had been professionally groomed and that grains were found on her body as well as in the blanket she was wrapped in, leading the police to believe that she may have been held captive in a bakery.

According to the information, told by the brothers Van K. and brother-in-law G. van L., this kidnapped girl absolutely did not want to cooperate with the rapes. If one of the brothers or brother-in-law Geert van L. wanted to go ahead with her, they first had to put up a whole fight with her. In the end she was permanently bound by this. The brothers' mother brought her food every day, but this victim spit this food right back in her face. For that reason, among other things, cigarette butts were pressed on her body. The victim continued to refuse food despite this. She was put to death.

Subsequently, her dead body was used to blackmail an elderly couple, whom the brothers could criminally use. The corpse was placed in the trunk of the car and the elderly couple were asked to drive along to perform another not fresh job. That elderly couple only understood what that job was when the car was parked in a wooded area and A. van Korlaar opened the trunk.

The elderly couple were then forced to remove the wrapped corpse from the car and carry it away. A. van K. took pictures of the elderly couple with the corpse. These photos have been placed with name and surname in the photo and film archive of the Van K brothers

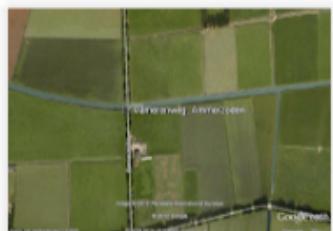

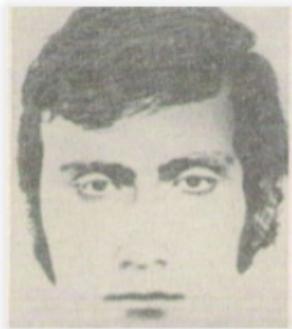
Pool created by the flooding of the Maas, in which the brothers kept a rowing boat and is located between the towns of Ammerzoden and Hedel in the floodplains on the Maasdijk. Driving by car from Ammerzoden on the Langedijkstraat which turns into the Maasdijk, one should turn left from the Maasdijk onto the Harenseweg and follow it to arrive at Hedel. It is not possible to follow the road from the Maasdijk by car, because the



Maasdijk is prohibited for cars from the Harenseweg exit. And it is precisely at that intersection Maasdijk/Harenseweg that meadow can be seen on the right.

**Hi Hovens, sergeant .. Pentecost May 29 ( 1967 ??) 1977**

HHTh.Hovens caught the brothers, Allesweter, Commissioner and Tweespaltmaker with their truck with drugs in the nature reserve on the heath near Tegelen. The brothers opened fire, leaving the sergeant dead, one last bullet being aimed at the back of the head.

At the end of the nature reserve, the truck was stopped by two officers, but they forgot the faces and the name on the door of the truck (K. flour trade) for a considerable amount of money. File 670/III/78 was closed unsolved in 1995.

**Mathilde Willink** (25-10-1977) Bullet through the left ear. **Robert Ter Haak**

**Tonnie van Maurik** (April 19, 1993) Shot in the head Parking lot Altea Hotel

**Klaas Makkinje** (June 10, 1999) Shot during a party in a building near the river.

**Cor van Hout** (1st failed attempt 1996) After the attack in December 2000, liquidation January 2003.

(was fatally injured during the liquidation of Cor van Hout) died Jan. 2003

**The business partner** of Erik de Vlieger. Parking lot company hall, shot in the head with a muffler, sitting in his car, causing the head to fall forward on the steering wheel.

**Anna Maria Lieven** (1999 in Malta) The wife of Hans Melchers (Melchemie) was murdered by order in Malta. against payment of 100,000,- of which 1/2 part was paid in advance in cash and 1/2 part after successful murder and paid for by the pilot of the private jet that brought the "Commissaris" and "Tweespaltmaker" to Malta on the night of the murder and flew back to the Netherlands after the murder. (See ATC Flt. Pln.LMML) the brothers were still in the jet. The Tweespaltmaker took the money and counted it on the spot before getting out and pushing the pilot a thousand.

**Andre Brilleman** – (February 1985)

**Sam Klepper** - October 10, 2000 by Kees van K. Adelbert van K. then went to the Hells Angels to declare the liquidation and placed Fl.150,000 on the counter of the Hells Angels base to arrange the funeral.

**Evert Hingst** October 31, 2005 (Bullets in the head and abdomen)

**John Mieremet** November 2, 2005.

**Kees Houtman** (November 2, 2005)

**Lawyer, Bram Zeegers** (October 9, 2007)

The wife of a couple who always came to the "Kalfje" on the Amstel in Amsterdam entered into a relationship with Bram Zeegers on behalf of the brothers. Bram Zeegers was a witness during the Holleeder case and was therefore drugged in October 2007 with a drug, developed from cerebrospinal fluid, which makes it completely willing. In his house, Zeegers was then administered an extra dose of MDMA and put in a hot bath by the Tweespaltmaker to make the drug work faster. supervised this liquidation.

**Victor 't Hooft** (November 7, 2007) -- Shot dead with a silencer by the Allesweter and not as people suggest Raymond P.)

**Henry du Long** December 11, 2007 drowning

On the north side of the Maas between the towns of Drongelen and Meeuwen is an inlet intended for the possible mooring of inland vessels. An ideal location for a drowning. Criminals always do this form of liquidation together. No matter how many victims were found there, the police conclude that it was a suicide. Henri du Long was drowned by the "Commissioner" and the "Discorder", because Henri du Long knew too much about the dealings of the criminal brothers.

The details are known.

**Jurjen and Marie Vis** ( September 2009 ) Shot and stab wounds in their home in Vollehove.

Jurrie graduated from the Erasmus University of Rotterdam in Business Administration and worked for a long time at Rijkswaterstaat, where he granted the Korlaar brothers a permit for the construction of apartment houses on the Maas near Nijmegen. Jurjen wanted to get rid of the brothers and even became a bridge keeper for this. It was to no avail.

**Aart de Lang and son Bas de Lang** from Hurwenen. (September 2008) Shot and set on fire. (Bas de Lang, son of one of the brothers of Korlaar, who gave birth to Aart's wife)

To erase DNA traces, Bas's body was set on fire.

Aart de Lang regularly transported large quantities of drugs for the brothers in his truck.

#### **Marijke Bonninga Furman/ the alias Jack Bonninga/Mathea.E.Sakko etc.**



The poignant story of Marijke Bonninga-Furman, whom the Allesweter, as a bigamist, was married to and still visits her at the clinic from time to time?

Marijke Bonninga-Furman has been admitted to a psychiatric hospital (Switzerland) and her children do not know of her existence. The Allesweter is married to Nel under his own name. (photos are available) and has two children.

Evert van K. was told by the Ndrangheta's main board that members of the Ndrangheta hid themselves by marrying women who were socially beyond any doubt. Those spouses then knew nothing about the activities of the spouse for the mafia, but were a cover. So Evert de Allesweter went to work under his false identity Jack Bonninga and, as the owner of a fleet of "hotel ships", contacted the Mensa association because people with high intelligence are affiliated with it. A nice researcher Marijke Furman was found with the right education to study law. Jack Bonninga (Evert), then courted her and married her around 1996 in Zaltbommel.



KB Marijke was then given the opportunity to complete a law study of 3 years in record time. She gave the Allesweter 2 daughters.

Evert drugged Marijke with an overdose of drugs from cerebrospinal fluid (this is a separate story and has to do with Kees van K.), which put Marijke in such an unstable and hopeless condition, which created a situation to eventually have Marijke admitted to a psychiatric hospital in Geldermalsen.



WB Her children, still small, were not aware of this, but Evert had to find a solution for this. Kees v. K. suggested that Evert, alias Jack Bonninga, make an arrangement at the registry office (through bribery) that he was married to Mathea Elisabeth Sakk. Kees had fathered a daughter Barbara with Mathea and foresaw major problems in his own marriage if this would escalate further. At the registry office of Zaltbommel, all records of the marriage of Evert van K./alias Jack Bonninga and Marijke Furman have disappeared, and all evidence of the Jack Bonninga and Marijke Furman's residence in Zaltbommel has also disappeared.
