

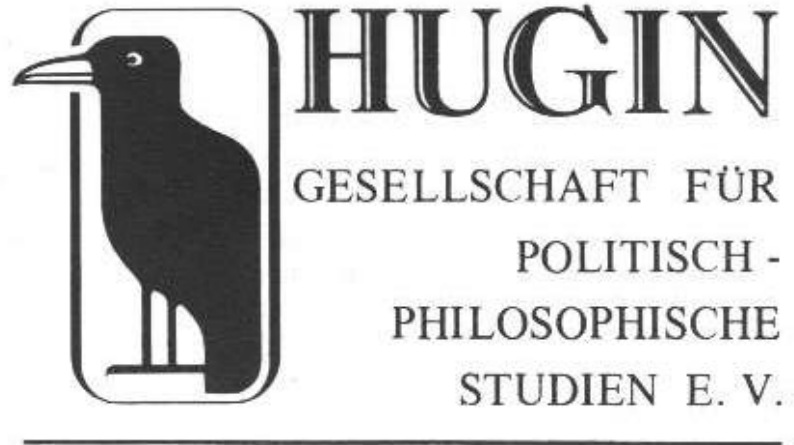

## Flying disc sightings around the world

For those readers who in the past have hardly dealt with the subject of flying discs at all, shall her aNumberofthemostknown andalso most spectacular events - which have been described in the 'UFO'-part are already described as the classic cases are known - in general.

The first step was to create a temporal distance between the two phenomena. However, since many reports from the year 1946, Scandinavia and also reports war about events from the classic years are clearly available, cases are prefixed:

*Supreme Headquarters, Allied Expeditionary Force, Dec. 13 - A new German weapon has appeared on the western front, it was revealed today.*

*American Air Force aviators reported encountering silver-colored bullets in the air over German territory. They encountered the spheres singly or in swarms. Sometimes they are almost transparent."*

The weekly magazine 'Neue Weltschau', No. 10 of 6 March 1980, wrote in a report about 'Ghost planes the from thousandsof People at 29.1.1980 via Klagenfurt and large parts of Austria were seen among others:  
*"Older residents admittedly remember the numerous UFO observations that took place over Klagenfurt and Carinthia during the Second World War - we reported extensively about it - and the whole incident is just as reminiscent of those*



*mysterious 'Air Defense Battle of Los Angeles' (this was also mentioned in our report), when, also during World War II, dozens of planes suddenly appeared on the coast, believed to be attacking Japanese fighters. They came under fire, were visible in the spotlight, and several were reported shot down. The fire spell lasted for hours*

*- the next morning, however, there was no trace anywhere of these mysterious invaders, who of course had not been Japanese, because at that time they could not fly so far.... Something similar was observed over Sweden in 1945/46, so-called 'ghost rockets', some of which flew over the sky with a loud noise, but were neither German, nor English, nor Russian (this can only mean that they had no corresponding nationality markings). For how else could one have known that at that time; author's note). Some of them allegedly crashed, but nothing was found, although American generals who had arrived in a hurry made every possible investigation together with their Swedish colleagues.*

From this report, we will first detail the incident over Los Angeles and later the one over Sweden. At February 25, 1942, about 15-20 unidentified enemy flying objects appeared over the California metropolitan area of Los Angeles, and the FLAK positions stationed around Los Angeles opened fire on them.

The London Times of 26.2.1942 reported this incident as follows:

*"ANTI-AIRCRAFT GUNS IN USE IN LOS ANGELES FALSE ALARM.*

*Self Report New York, Feb 25 Anti-aircraft guns were used over Los Angeles last night for the first time since the beginning of the war. The first alarm was sounded at 2:25 a.m. (Pacific time) was given. Almost immediately thereafter began*

See also the document (SECRET- stamped), reproduced in the Appendix, kept secret for 30 years (until May 3, 1972), "Memorandum for the President (Roosevelt)," by Chief of Staff Gen. C. Marshall. The document makes clear the event taken seriously by the highest authorities. It states:

1. Unknown Aircraft were probably via Go

Angeles, and were fired upon by batteries of the 37th CA Brigade between 3:12 and 4:15 a.m. with 1430 rounds of ammunition.

2. About more than 15 aircraft between 'very slow' to 200 miles and flying between 3000 and 6000 meters altitude were involved.

3. No bombs fell.

4. No troop losses in our country (USA).

5. No aircraft was shot down.

6. Army or Navy aircraft of the Americans were not in action.

"Frankfurter General Newspaper 20.10.1979:  
*"The 'foo fighter,' a small ball like the one used during the World War II is said to have appeared on both sides, was apparently a reconnaissance aircraft and unmanned."*

*"Die Welt"*, Hamburg, of 3.10.1950 reports a case where these balls had a diameter of only 30 cm.

Of course, there have been not only unmanned but also manned flying discs or flying bullets, even during the war years.

*"In World War II and the Korean War, 'foo- fighters' (unidentified lights or objects that accompanied bombers or fighter planes on their missions) were fairly commonplace." S. 241*

Rufus Drake's detailed report, "Secret U.S. Nuclear Facilities Monitored by UFOs; Saucers over Hanford/Washington," appeared in 'UFO Report,' Spring, USA, pp. 38-41, 60-62.

The following occurred in the Bermuda area in December 1944:

*"In Europe, the war was in full swing; the Americans had already landed in Italy and were fighting the Germans doggedly in the air and at sea; both sides were suffering heavy casualties. In order to reduce losses to the 75th U.S. Air Fleet*

American bombers entered the United States. After a stopover in Bermuda to refuel, flew  
they continued. 480 km from Kindley Field, the formation suddenly encountered numerous strange meteorological phenomena. 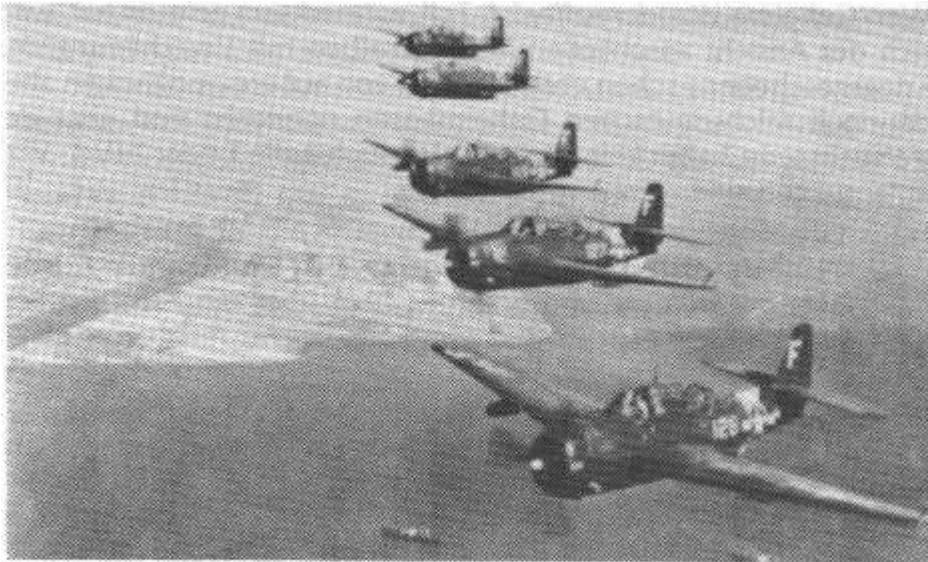

They all witnessed the strange demonstration among the clouds. In view of this group of trustworthy persons, any doubt about the credibility of the observation is excluded. They had not waited long when a monster of at least 170m in diameter appeared. It was a new type of saucer, which emitted explosive red flames. Of course, the spectacle was not enjoyed in peace, but preparations were immediately made to uncover the mystery. Three fighter planes had already taken off, and were hunting for the intruder. Captain Mantell, the leader of this fighter group made contact with the people in the watchtower.... It turned out that the*

### 500 flying discs over Farmington !

On March 17, 1950, at 11 o'clock in the morning, Sheriff Mc Graw was suddenly called outside. The skies of the U.S. oil town of Farmington in northwestern New Mexico were teeming with flying discs. Also on the radar screens of the air surveillance one had discovered the gigantic swarm of strange flying objects in the meantime. The sheriff estimated that there must be about 500 unknown objects,

and they flew onto the hermetically sealed nuclear exclusion zone of the United States. The same was repeated at about the same hour on March 18 and 19, 1950.

# Jagd auf Lichtflecke

wurde, bekam keinen der „Lichtflecke“ zu Gesicht.

Während der Sprecher der Luftstreitkräfte die Möglichkeit einräumte, daß die Beobachter einer optischen Täuschung, einer „technischen Merkwürdigkeit“ oder einer anderen „verrückten Sache“ zum Opfer gefallen sein könnten, bestand der Sprecher des Flugsicherheitsdienstes darauf, daß es sich „mit Sicherheit“ um „feste“ fliegende Gegenstände gehandelt habe. ## STRANGE OBJECTS IN U.S. SKY

### OBSERVATION BY RADAR

FROM OUR OWN CORRESPONDENT

WASHINGTON, JULY 22

United States Air Force officials, who have been checking the many recent reports of "flying saucers" submitted to them from various parts of the country, are to-day investigating reports that seven to 10 "unidentified aerial objects" were noted on radar screens here early on Sunday morning. These objects appeared to be over Andrews Air Force base, in Maryland.

The Air Force announced last night that the objects had appeared on the radar screen in the air route traffic control centre at the National Airport, first on one section of the screen, and then, soon afterwards, on another section, which showed them moving in a different direction. Their speed was only 100 to 135 miles an hour, which is very slow for "flying saucers." One pilot watched the objects for about 12 minutes as he flew from Washington to Martinsburg, in West Virginia. Another pilot reported that a brilliant light had followed his aircraft from Herndon, in Virginia, to within four miles of the National Airport.

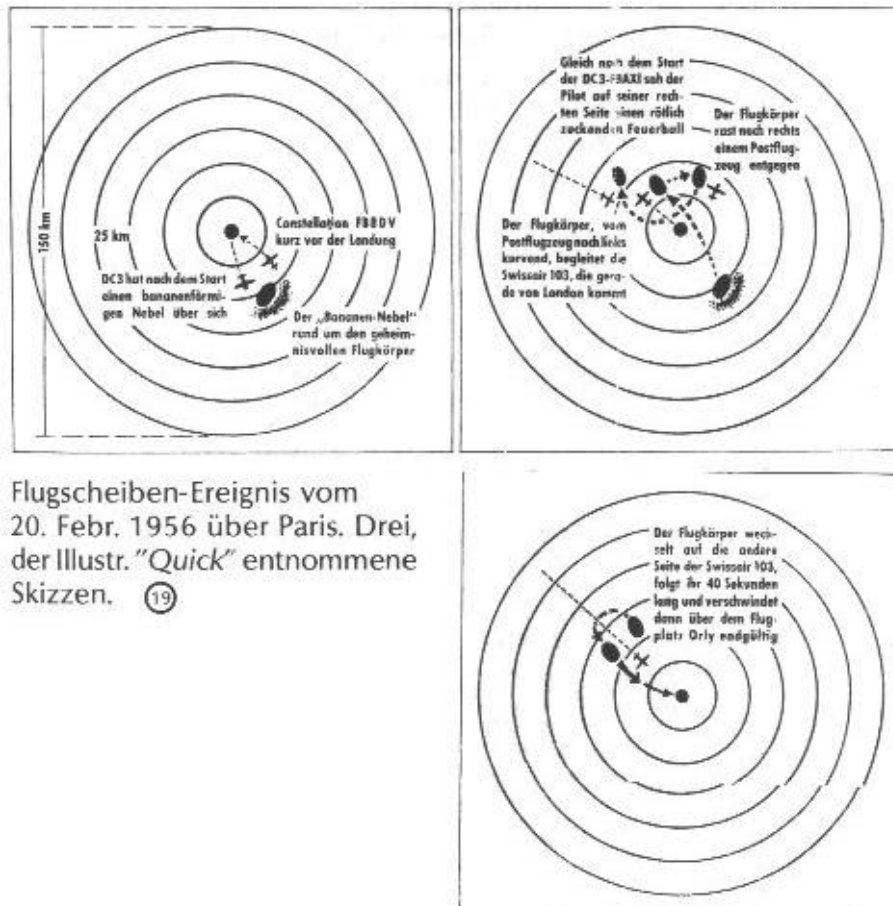

On November 6, 1954, about 100 'flying saucers' stayed in the sky over Rome for more than two hours (from 11 am to 1:30 pm). At exactly 12 o'clock, 40 of them formed a huge cross in the sky, in such a way that two groups formed a big 'V'. Each V consisted of 2x10 flying discs. These two V-formations flew with their tips towards each other. When these two formations were together with the tips, they stopped motionless.

### **Fear and terror in Petrozavodsk!**

From Sept. 20, 1977 to Feb. 20, 1978, a UFO as large as a soccer field appeared 5-6 times a month over the Soviet city of Petrozavodsk (population 185,000) on Lake Onega, northeast of Leningrad.

One of the largest newspapers in the USA, the *'National Enquirer'* reported about it in detail on April 18, 1978, after the two chief editors of the million-dollar paper William Dick and Henry Gris had traveled to Moscow, Leningrad and the city of the event itself especially for this event. Thanks to their good contacts with journalists there and Soviet Scientists we owe their detailed report.

The National Enquirer wrote:

*"The Soviet Government appointed me a scientific research at the highest level and put a security bar on this investigation. However, the Enquirer managed to pierce the cloak of official secrecy surrounding this incident and obtained exclusive interviews with a reporter from Tass, the official Soviet news agency and Soviet Top Scientists to Lead."* No. 251, June 1978, p. 7

Now on this 20th Sept 1977 afternoon 4pm the following happened. A huge 'UFO' appeared over the city for about 12 minutes and sent out golden rays of light, which fell on the city like spray and burned coin- to egg-sized holes in cobblestones of the streets and in windowpanes of many houses. It is also said that five intense rays of light from the huge object were directed at the city, and Petrozavodsk was enveloped in this golden light during these 12 minutes. Literally, the W. Dick and H. Gris report states:

*"Window panes with holes of various sizes caused by the UFO's light beams were seized by government researchers" op. cit.*

The Correspondent the Soviet News Agency TASS, Nicolai Milov, the hundreds of Citizen in Petrozavodsk interviewed, described one of the holes, something larger than a chicken egg, which was burned into the window pane of an apartment building. Amazingly, the piece of glass that was cut out remained whole and was found on the floor in front of the window. The pane was transferred to Moscow as part of the investigation. Milov literally to the Americans:

*"After interviewing them (the eyewitnesses; author's note), there was no doubt in my mind that I had met people here who had been confronted with a tremendous event.*

*Some were hysterical... As a Group from dockworkers who were working in the port saw the UFO, they ran away screaming: 'This is the end!' They believed to recognize in the body a nuclear weapon which had been sent out by your country (USA) and could explode any moment over their heads. They were out of their minds with fright." op. cit.*

With the many other 50-70 mm holes it was



similar. The separated circular pieces of glass seemed to be on the edges like melted and lay either on the window sills or at the floor. double glazed Windows remained both panes - apart from the separated round pieces - undamaged. According to this 12 minutes Event via the Capital the north russia Provinc Karelia, hovered the strange Flying slow in Direction Port/Onega-Seedavon . Vladimir Azhazha, Moscow physicist, oceanographer, author and Lectur and former Soviet Submar Commander stated:

*"The object flew low over the harbor and hovered above an anchored ship 142 meters long. A comparison with the length of the ship led to the conclusion that the diameter of the UFO was 104 meters. As the UFO flew toward Lake Onega, many drivers took up pursuit. The UFO hovered motionless over the lake. After a while, a smaller object separated from the main body, fell straight down and disappeared under the water. At that moment, the main body (the UFO) suddenly started moving and quickly disappeared into a cloud bank."*  
op. cit.

The Enquirer report goes on to say:

*"A senior editor of TASS reported that the news agency received over 1500 letters inquiring, 'How safe is it still to be in Petrozavodsk to stay or travel there?' Before TASS was able to respond Letter RSVP could, were the Writing s Government moved in. Also Fro Eyewitness accounts were brushed aside, the TASS editor told the Enquirer. ..."*

*Professor Felix Zigel, Russia's top expert on UFOs and a teaching professor at the Moscow Aviation Institute, an academy where Soviet cosmonauts receive their specialized training, also thinks the object is a UFO. 'Without a doubt,' he told the Enquirer. 'It had all those characteristics.' " op. cit.*

However, in the further UFO appearances over Petrozavodsk in the following months, no more holes were burned in street pavements and window panes. The full National Enquirer report of April 18, 1978, appeared, translated into German, in UFO News, June 1978, No. 251, p. 7

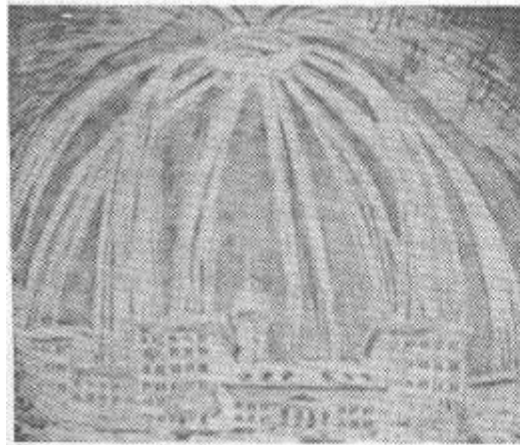

# 'OBJECTS' OUTSTRIP JETS OVER CAPITAL

Spotted Second Time in Week  
by Radar, but Interceptors  
Fail to Make Contact

By The Associated Press.

WASHINGTON, July 27—The Air Force said today that jet fighter planes had made an effort to intercept unknown objects in the sky over Washington last night after the objects had been spotted by radar, but that no direct contact had been made.

It was the second time within a week that unidentified objects had been observed in the vicinity of the nation's capital, but no planes were sent up on the previous occasion, last Monday.

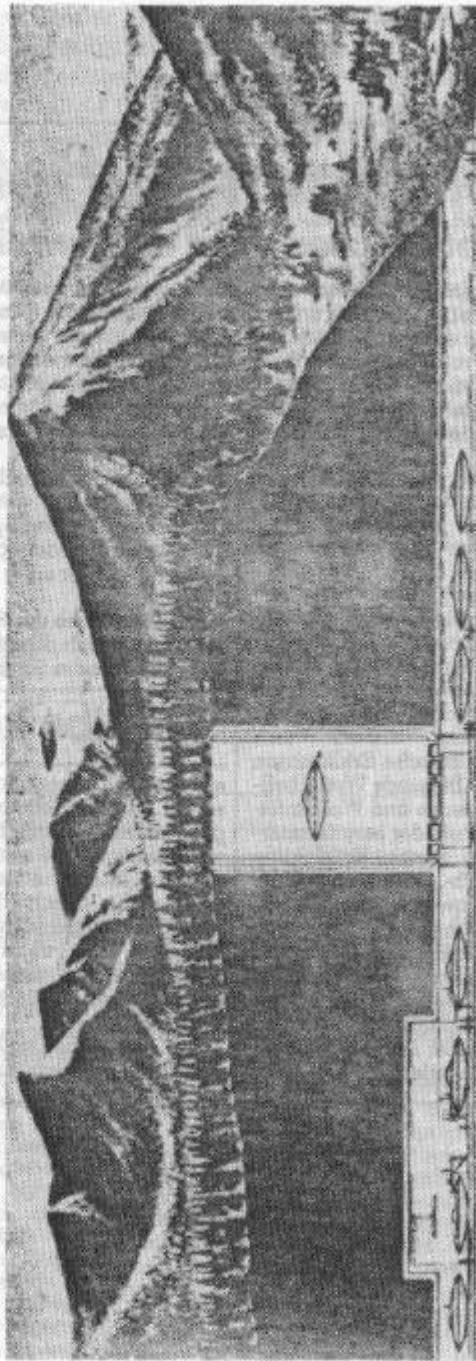
The Air Force said that at 9:08 o'clock, Eastern daylight time, last night the Air Route Traffic Control Center, operated by the Civil Aeronautics Administration, had picked up by radar "between four and twelve unidentified objects over the Washington vicinity."

The C. A. A. notified the Air Force and two jet fighter-interceptor planes were ordered up to make a check. These planes came from a base at New Castle, Del., about ninety miles from Washington.

The jet planes themselves appeared on the C. A. A. radarscope at 11:23 P. M. and were guided in on some of the unknown objects.

The Air Force, and its investigating agency, "Project Bluebook," are aware of Major Keyhoe's conclusion that the "Flying Saucers" are from another planet. The Air Force has never denied that this possibility exists. Some of the personnel believe that there may be some strange natural phenomena completely unknown to us, but that if the apparently controlled maneuvers reported by many competent observers are correct, then the only remaining explanation is the interplanetary answer.

# Invasion „fliegender Untertassen“ in Frankreich und Deutschland?

Von unserem Pariser Korrespondenten

**Hu. Paris (Eig. Bericht).** In Frankreich sind in der Nacht von Montag auf Dienstag fliegende Untertassen in großer Zahl beobachtet worden. Zahlreiche Menschen in verschiedenen Teilen des Landes, aber auch in Holland, der Schweiz und der Bundesrepublik berichteten, gegen 1.15 Uhr nachts hellleuchtende, im allgemeinen in westöstlicher Richtung fliegende Objekte gesichtet zu haben. Einige Augenzeugen geben sogar an, eine ganze Gruppe von fliegenden Untertassen habe sich geräuschlos und schnell in großer Höhe vorwärts bewegt. Daß es sich bei den Beobachtungen um Halluzinationen handelt, ist ausgeschlossen, weil auch die Besatzungen von acht Passagierflugzeugen, die sich zu der genannten Zeit über französischem Staatsgebiet befanden, dem zentralen Flughafen (Kontrollturm Paris-Orly) meldeten, sie hätten hellstrahlende Flugobjekte gesichtet.

Die Beobachtungen der Flugzeugbesatzungen wurden an so entgegengesetzten Punkten wie Straßburg und Marseille gemacht, so daß bloße Luftspiegelungen nach allgemeiner Überzeugung ausscheiden. Nachdem vom Kontrollturm in Orly in den frühen Morgenstunden des Dienstag die Beobachtungen der Flugzeuge zunächst bestätigt wurden, ist im Laufe des Vormittags ein offenbar von militärischer Seite veranlaßtes Dementi herausgegeben worden.

Es scheint aber festzustellen, daß die zivilen Luftkontrollbehörden die militärische Luftverteidigung alarmiert haben, nachdem es ihren eigenen Radargeräten nicht gelungen war, die unbekannten Flugkörper zu erfassen. Von militärischer Seite hat man anscheinend ebenfalls keinen Erfolg gehabt.

Vom amerikanischen Luftwaffenhauptquartier für Europa wurde bestätigt, daß man die unbekannten Flugobjekte ebenfalls auf den Flugplätzen Ramstein und Spangdahlem gesichtet hat, aber aus ungenannten Gründen nicht mit Radar erfassen konnte.

Auch an Bord von zwei englischen Schiffen, die sich im Kanal zwischen England und Frankreich beziehungsweise vor der niederländischen Küste befanden, sind die fliegenden Untertassen festgestellt worden. Das Observatorium von Meudon bei Paris hat für die Beobachtungen in der Nacht zum Dienstag eine einfache Erklärung bereit. Wenn es sich nicht um Kometen gehandelt habe, so meint das Observatorium, dann seien die zahlreichen Beobachter fliegender Untertassen wohl Augenzeugen des Eintritts eines

sowjetischen Satelliten in die Erdatmosphäre gewesen. Der Feuerschein sei entstanden, als der Satellit durch die Berührung mit der Luft zerrieben wurde.

Von verschiedenen Orten Südwestdeutschlands aus ist zur gleichen Zeit ein „unbekanntes fliegendes Objekt“ am Sternenhimmel gesichtet worden. Es wurde vom Bodenseegebiet und vom Schwarzwald aus kurz nach ein Uhr früh beobachtet. Drei Werkschutzangehörige einer Konstanz-Firma beschrieben den Gegenstand unabhängig voneinander als etwa zehn Meter langen, rotglühenden Flugkörper, der langsam von West nach Ost geflogen sei. Nach Ansicht der Beobachter war er weder ein Meteorit noch ein Flugzeug. Er habe einer glühenden Rakete mit langem Schweif geglichen.

Sehr geehrter Herr Malter!

Bedauerlicherweise gibt es im britischen Verteidigungsministerium keine Stelle, die allein mit dem Aufgabebereich des Vorkommens von UFOs aufzuarbeiten und es gibt auch keine Mitarbeiter, die sich diesem Thema während ihrer gesamten Arbeitszeit widmen. Die über das Thema existierenden Unterlagen fallen unter den Public Records Act, was bedeutet, dass erst 1993 die ersten Unterlagen freigegeben werden. Deshalb muss ich Ihnen mit diesem Bedauern mitteilen, dass ich Ihnen nicht behilflich sein kann.

Dann hat mir jedoch mitgeteilt, dass es keine Beweise gibt, die darauf hindeuten, dass die Beobachtungen, die man über Grosvenor-Leuchten gemacht hat, außerordentlichen Dringungs waren.

Ich wünsche Ihnen alles Gute für Ihre Studien und verbleibe

## Geheimnisvolle Stahlkuppel im ewigen Eis

Alle elektrischen Bordgeräte der Flugzeuge fielen aus — Amerikaner stehen vor einem Rätsel

Die in den fast ständig zugefrorenen Häfen Alaskas stationierten amerikanischen Marineaufklärungsflieger sind vom Kommando der Luftüberwachung in Alaska alarmiert worden. Seitdem kreuzen sie tausende Kilometer weit über den Nordpol, um an einem in ihrer Karte eingetragenen Punkt nach einer geheimnisvollen Stahlkuppel zu suchen. Ein strategischer Bomberverband auf Manöverflug hatte diese Kuppel vor einem Monat zum erstenmal 1000 Seemeilen nordöstlich der De-Long-Inseln im ewigen Eis gesichtet.

Der Pilot des damals im Probeneinsatz befindlichen Strahlentriebwerk-bombers berichtet: „Der monotone Flug über die endlosen Flächen des ewigen Polareises wurde plötzlich unterbrochen. Ich wies meinen Bordfunker auf eine stählern glänzende Kuppel zwischen Eisbarrieren hin, die sich 3000 m unter uns türmten. Die Kuppel war blaugrau und drehte sich wie der gepanzerte Gefechtsurm einer Festung oder nach Art eines Radargerätes. Wir peilten das Ding an und funkten. Dabei gingen wir auf 800 m herunter. Da sahen wir deutlich wie die Kuppel sich auf einer Drehscheibe oder einer Riesenwelle bewegte. Plötzlich mußte man unsere Funksignale vernommen haben. Die Kuppel drehte sich nicht mehr und verschwand blitzschnell wie ein Fahrstuhl in der Tiefe. Darüber schoben sich waagrechte Schotten, auf die sich von der Umgebung nicht zu unterscheidendes Eis getürmt war.“

Der Funker dieses Bombers berichtet, daß während des ganzen Anfluges auf die geheimnisvolle stählernen Kuppel im Nordpolareis sämtliche elektrischen Bordgeräte unmittelbar nach dem Funk-

anruf für Unbekannt ausfielen. Diese Beobachtung im ewigen Eis ist wahrscheinlich höchst sonderbar. Die Stellen des Aufklärungskommandos in Alaska fragen sich, ob es sich um einen vorgeschobenen Beobachtungs- und strategisch wichtigen Posten einer anderen Macht handelt? Das Eisgebiet, wo die Bomberbesatzungen die Wahrnehmung machten, ist umstritten. Die USA und die UdSSR beanspruchen es für sich. Es gilt als „Exklave des Geophysikalischen Jahres“.

Besonders zu denken gibt der Ausfall aller elektrischen Bordgeräte. Sollte mit radiotechnischen Störmitteln, die sogar die Tourenanzeiger zittern ließen, etwa alle Positionsmessungen unmöglich gemacht werden? Seit der Meldung der Bomberbesatzung führten Aufklärer 19 Patrouillenflüge über dem mysteriösen Gebiet durch. Aber 1000 Seemeilen nordöstlich der De-Long-Inseln klart das Wetter nur selten auf. Dort unten zwischen Schneesturm und peitscherndem Eissturm müßte die geheimnisvolle Stahlkuppel liegen.

Seitdem die Entdeckung gemacht worden ist, melden die verschiedensten Küstenstationen Alaskas Funksignale, die offenbar verschlüsselt sind und die aus besagter Gegend zu kommen scheinen. Flugzeuge, die die „Funkspur“ aufnahmen, kamen bald in die Nähe der genau festgelegten Position. Immer wenn sie sich jedoch über mehr als 20 Meilen der „versenkbaren Station“ nähern, schweigt der rhythmische Morsetakt. Das strategische Kommando Alaska nimmt an, daß es sich um eine geheim gehaltene Forschungsbasis einer unbekannten Macht handelt. Dort, im unzugänglichen Nordpolgebiet einen militärischen Stützpunkt zu unterhalten, wäre nach Meinung der Amerikaner unsinnig, es sei denn, andere hätten das Problem der Versorgung in der „Wäldnis der Eisbarrieren“ gelöst und wüßten, Fernraketen während der 333 Sturmzüge im Jahr von dort auf die Reise zu schicken. Beobachtungsflieger der Luftwaffe und Marine hoffen, im Interesse der Sicherheit, schon recht bald das Rätsel des geheimnisvollen Punktes lösen zu können.

# Grüne Männchen in Spanien?

ROLF GÖRTZ, Madrid

„Doch alles Schwindel, die Geschichte mit den fliegenden Untertassen. Wir haben keine gesehen. Nicht Ufos haben unsere Maschine zur Landung gezwungen, sondern irgendein technisches Versagen.“ So wetterten 109 deutsche und österreichische Fluggäste des TAE-Charterfluges Frankfurt — Palma de Mallorca — Teneriffa. Ihre Caravelle war nicht auf den Kanarischen Inseln, sondern bei Valencia gelandet. Was die Passagiere bis dahin nicht wußten: die spanische Luftwaffe hatte zu ihrem Schutz vier Phantom-Jäger in den Nachthimmel geschickt. Ein Geschwader-Kommandore hatte die unbekannten Flugobjekte und den Hilferuf des TAE-Piloten Tejada ernst genommen.

Planmäßig war die Maschine des Charter-Unternehmens „Spanische Lufttransporte“ (TAE) in Palma de Mallorca gestartet, mit Kurs auf die Kanarischen Inseln. Über Evisa entdeckte die Besatzung auf dem Radarschirm mehrere Signale, die sich „merkwürdig schnell näherten“. Flugkapitän Tejada rief den Kontrollturm des Flughafens Valencia an: „Sind Flugzeuge auf unserer Route?“ Antwort: „Nein, keine Meldun-

gen.“ Dann sahen Tejada und der Kopilot „rote schillernde Lichter, die sich irgendwie verrückt bewegten“ (Tejada).

Die Besatzung hatte das Gefühl, daß unbekannte Flugobjekte ihre Caravelle verfolgten. So bat Tejada den Kontrollturm von Los Manises bei Valencia um Landeerlaubnis. Gegen elf Uhr nachts rollte die Maschine dort aus. Kurz vorher brauste eine Staffel von vier Phantom-Jägern über den Platz — und die unbekannten Flugobjekte verschwanden wie auf Kommando.

Flugleiter des Kontrollturmes und Angestellte und Arbeiter auf der Piste bestätigten, was die Piloten gesehen hatten: ein rotes Licht, das sich über dem Kontrollturm aufhielt, ein zweites über der Piste, ein drittes über dem nahe gelegenen Militärflughafen. Alle in etwa dreitausend Meter Höhe. Ein viertes Licht kreiste in größerer Höhe über der gesamten Region.

Ohne sich über die Beschaffenheit der Lichterscheinungen zu äußern, nehmen die spanischen Luftwaffenoffiziere die Ufos ernst. Auch die Marine sammelt Beobachtungen. Der Journalist Benitez erhielt für seine Zusam-

menstellung mehrfach Berichte von Luftwaffe und Marine.

Aus diesen Berichten geht klar hervor, daß die spanischen Streitkräfte an der Existenz unbekannter Flugkörper nicht mehr zweifeln. Allerdings werden nirgendwo Flugobjekte von anderen Sternen, überirdische Wesen — gar die kleinen grünen Männchen — als Urheber dieser Erscheinungen erwähnt. Sorgfältig werden jedes Mal Marinemeteorologen eingesetzt, die ergründen sollen, ob irgendwelche meteorologischen Erscheinungen hinter den unbekannten Lichteffekten stecken könnten. Immerhin scheint sich das Interesse der Ufos auf strategische Punkte zu konzentrieren. Gibt es bemannte oder unbemannte Flugsonden, deren Existenz die Großmächte bisher verschweigen und die sich bereits gegenseitig beobachten, fragen sich denn auch die Skeptiker.

Auf ganz anderem Gleis reisen die fanatischen Storys über die kleinen grünen Männchen, die aus soeben gelandeten Apparaten klettern, spanisch sprechen und manchmal gar nicht klein und grün sind. Sie tauchen vor allem in jenen entlegenen regenfeuchten Dörfern des Baskenlandes auf, wo man früher sehr intensiv an Hexen glaubte. (SAD)

Sahen aus wie Omnibusse**Geheimnisvolle Flugkörper über Argentinien****Glaubwürdige Augenzeugen — Brennstoffproben werden untersucht**

Buenos Aires, (dpa) Argentinien soll in der letzten Zeit von einer Invasion fliegender Untertassen heimgesucht worden sein. Eine Reihe von vertrauenswürdigen Personen berichtete über „leuchtende Körper“, die ein ungewöhnlich starkes Licht ausstrahlen. Übereinstimmende Aussagen liegen aus Mendoza, Corboda und Bahia Blanca in der Provinz Buenos Aires vor.

Die seltsamste Geschichte berichteten zwei Brüder. Sie fuhren in einem Lastwagen, als sie in hundert Metern Entfernung von der Straße auf dem Erdboden einen Gegenstand erblickten, der so ähnlich wie ein Eisenbahnwagen oder ein Omnibus aussah. Er hatte etwa 20 Öffnungen, aus denen abwechselnd starke Lichtstrahlen blitzartig hervorbrachen. Die beiden Brüder gingen auf den Gegen-

stand zu, der sich aber steil in die Luft erhob, als sie sich ihm auf etwa 70 Meter genähert hatten. Dabei zeigte es sich, daß es in Wirklichkeit zwei Fahrzeuge waren, die sich in der Luft von einander trennten und rasch davonschwebten. Später fanden die Brüder an der Landestelle des Flugkörpers Brandspuren am Boden. Die Erde war steinhart, das Gras niedergedrückt und Insekten versengt, außerdem fanden sie Spuren einer grauen Flüssigkeit, die wahrscheinlich vom Brennstoff des Fahrzeuges stammte. Erdproben und Proben der Flüssigkeit wurden von der Universität Bahia Blanca der Marinestation Puerto Belgrano und der argentinischen Atomkommission untersucht. Bisher wurde lediglich die Untersuchung der Bodenproben der Universität Bahia Blanca bekannt. Danach enthielt die Erde Spuren von Pottasche-Karbonat und Kalk, die sich in jener Gegend an keiner anderen Stelle fanden.

**Unbekannte Flugkörper über Sydney****Rundfunk und Zeitungsredaktionen mit Anrufen überschwemmt**

Mehrere hundert Menschen überhäuften am Wochenende in Sydney die Radiostationen und Zeitungsredaktionen mit Telefonanrufen, nachdem über Neusüdwaales eine Formation heller, sich schnell bewegendes Flugobjekte gesichtet worden war. Von der australischen Luftwaffe wurde dazu mitgeteilt, daß in dieser Zeit keine Flugzeuge in Formation über Neusüdwaales aufgestiegen seien.

Mister Richardson aus Leppington schildert seine Beobachtung mit den Worten: „Es war eine unheimliche Erscheinung. Kein Geräusch, nur eine ständige Bewegung von acht Lichtern in geschlossener Formation. Sie waren zu schnell für Flugzeuge und zu langsam für einen Meteor.“

In Washington hat die Luftwaffe der Vereinigten Staaten mitgeteilt, daß 363mal in der Zeit von 1947 bis 1965 nicht identifizierte „Rhein-Neckar-Zeitung“, Heidelberg, 8.3.1965

Flugobjekte gesichtet worden seien. Es sei aber kein Anhaltspunkt dafür gegeben, daß die Flugkörper nicht von der Erde stammen. Der Luftwaffe seien in diesem Zeitraum 8908 Berichte über „Fliegende Untertassen“ und andere Flugobjekte bekannt geworden.

**Fliegende Untertassen über Rom**

Rom, (upi) Mindestens ein Dutzend Menschen berichteten gestern, eine fliegende Untertasse über Rom gesichtet zu haben. Obwohl die Personen die Erscheinung an verschiedenen Stellen der Stadt und in den Albaner Bergen beobachteten, gaben sie eine im wesentlichen übereinstimmende Schilderung des unbekannten Flugobjekts. Die Luftfahrtbehörden von Rom teilten jedoch mit, daß die verschiedenen Piloten, die zu der Zeit der Erscheinung über Rom flogen, die Untertasse nicht gesehen haben. Auch auf den Radarschirmen konnte der Flugkörper nicht ausgemacht werden.

**F**lugkapitän Denis Wood von „British Airways“ hat Zeugen und kann den offiziellen Auftrag zur UFO-Verfolgung vorweisen. Somit ist er erhaben über Zweifel, an dem, was er im Sommer 1976 beim Flug von London nach Faro in Südportugal beobachtete. „Ich sichtete mit der gesamten Crew meines Flugzeuges zwei zigarrenförmige Flugobjekte (UFOs), die die Größe je eines Schlachtschiffes besaßen. Ich habe mir mehrere Monate zum Überdenken auserbeten, aber nun muß ich doch bekennen, daß wir alle uns entschlossen haben, zu diesen UFO-Sichtungen zu stehen, wenn wir diese riesigen Flugkörper auch nicht erklären können. Vielleicht war es ein Materialisierungs-Phänomen, mit dem unsere Wissenschaftler noch nichts anzufangen wissen. Ich frage mich seitdem nun aber täglich, welche Mächte es sind, die sich auf diese Weise in unserem Luftraum bewegen und was sie eigentlich vorhaben...“

Flugkapitän Denis Wood hat 20 Jahre Flugerfahrung. Und er hatte die UFOs nicht etwa selbst entdeckt und gemeldet. Vielmehr war seine Crew von der Flugkontrolle Lissabon aufgefordert worden, auf ein

unbekanntes Flugobjekt zu achten. „Und dann tauchten die weiß leuchtenden Dinger schon vor meinen Augen auf. Unglaublich, rief mein Co-Pilot im gleichen Augenblick aus. Ihm blieb 20 Sekunden der Mund offenstehen. Das ist eine lange Zeit. Es sah aus, als handele es sich um ein großes Mutterschiff, aus dem zwei zigarrenförmige Gebilde zur Erkundung starteten.“

Unabhängig voneinander sagen Besatzungsmitglieder und Fluggäste aus, es habe sich um vollkommen feste Körper von der Größe von Schlachtschiffen gehandelt. „Ich verstehe nicht, daß man beim Vorhandensein mehrerer Augenzeugen und aufgrund des Auftrags zur Verfolgung durch den Kontrollturm von Lissabon immer wieder versucht, uns einzureden, es habe sich wohl um Satelliten, Ballons, seltsame Wolken oder Lichtreflexionen gehandelt. Schließlich können wir nicht dafür, daß die Forschung im dunkeln

tappt und Wissenschaftler keine Erklärung finden. Mein Co-Pilot meint, diese Flugobjekte hätten vor der Materialisierung offensichtlich die Zeitwand durchstoßen und seien dadurch erst in unser Wahrnehmungsvermögen gelangt...“

Die Objekte waren auch auf dem Radar sichtbar. Sie wurden sogar von einer anderen britischen und einer portugiesischen Maschine gesichtet und gemeldet. # Flugzeug-Besatzung sah Zigarren-Ufo

## Kapitän: Objekte auch auf dem Radar

**London.** (dpa) Die Besatzung einer Maschine der „British Airways“ hat zwei zigarrenförmige Flugobjekte (Ufos) gesichtet, die die Größe von Schlachtschiffen besaßen.

Dies wurde am Freitag in London durch Aussagen des Flugkapitäns Denis Wood, der 20 Jahre Flugerfahrung hat, und seiner Crew bekannt. Sie hatten die unbekannten Objekte im Sommer letzten Jahres beim Flug von London nach Faro in Südportugal beobachtet.

Die britische Maschine war von der Flugkontrolle Lissabon aufgefordert worden, auf ein unbekanntes Flugobjekt zu achten. Kurz darauf sahen Kapitän Wood und seine beiden Offiziere im Westen ein weißleuchtendes rundes Objekt.

Während sie es noch beobachteten, materialisierten sich in der Nähe dieses Objekts zwei riesige zigarrenförmige Gebilde. „Sie waren absolut solide und schätzungsweise von der Größe von Schlachtschiffen“, erklärte Kapitän Wood. „Vermutungen, daß es sich um Ballons, Satelliten, seltsame Wolken oder Lichtreflektionen handelte, sind für uns ganz unakzeptabel.“

Die Objekte waren auch auf dem Radar sichtbar und wurden auch von den Besatzungen einer anderen britischen sowie eines portugiesischen Flugzeuges gesichtet und gemeldet. Als Kapitän Wood von Faro nach London zurückflog, waren die beiden „Zigarrenschiffe“ immer noch da. Dann jedoch verschwanden sie vom Radarschirm.

MEMORANDUM FOR THE PRESIDENT:

The following is the information we have from GHQ at this moment regarding the air alarm over Los Angeles of yesterday morning:

\*From details available at this hour:

"1. Unidentified airplanes, other than American Army or Navy planes, were probably over Los Angeles, and were fired on by elements of the 37th CA Brigade (AA) between 3:12 and 4:15 AM. These units expended 1430 rounds of ammunition.

"2. As many as fifteen airplanes may have been involved, flying at various speeds from what is officially reported as being 'very slow' to as much as 200 MPH and at elevations from 9000 to 18000 feet.

"3. No bombs were dropped.

"4. No casualties among our troops.

"5. No planes were shot down.

"6. No American Army or Navy planes were in action.

\*Investigation continuing. It seems reasonable to conclude that if unidentified airplanes were involved they may have been from commercial sources, operated by enemy agents for purposes of spreading alarm, disclosing location of antiaircraft positions, and slowing production through blackout. Such conclusion is supported by varying speed of operation and the fact that no bombs were dropped."

Anti-aircraft batteries went into action over Los Angeles last night for the first time since the war began. The first alert was sounded at 2.25 a.m. (Pacific time). Almost immediately anti-aircraft fire began, and about 30 searchlights roved over the sky, concentrating in a few minutes on a vague object high in the air. Meanwhile the city and all the surrounding country went into a black-out. The firing of guns ceased at 3.30 a.m. At 4 a.m. it was resumed for a time. The "all clear" was not sounded until 7.19 a.m.

This afternoon Colonel Knox, Secretary to the Navy, said it was "just a false alarm"; there were no aeroplanes over Los Angeles.

During the alarm the police arrested three Japanese suspected of sending flashlight signals.

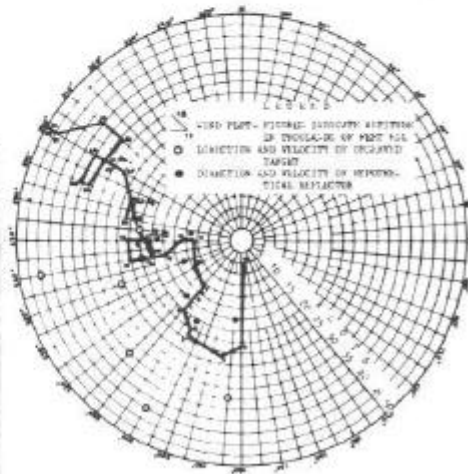

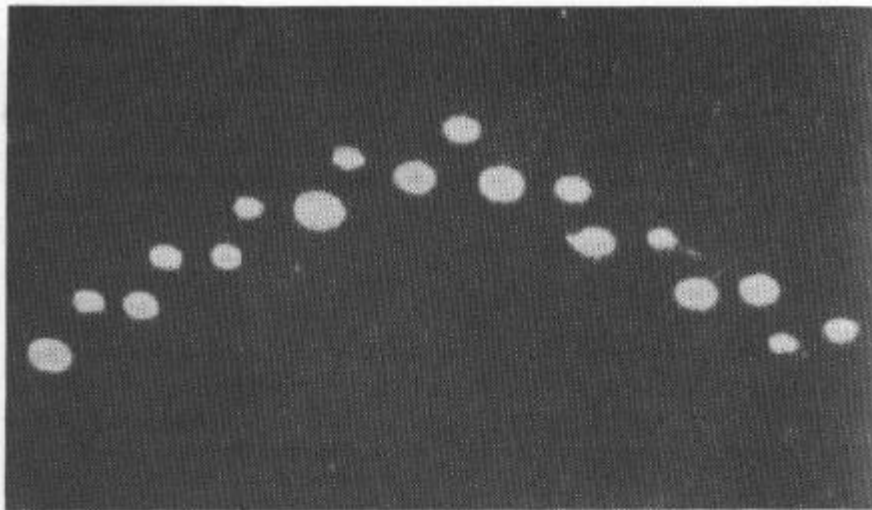

Zwei Männer seien erschienen und hätten ihn angeleuchtet. Für eine Sekunde habe er sich nicht rühren können. Dann sprachen die beiden Männer, erzählte Schmidt. Anstelle der Marsprache, die er erwartet haben mochte, will er aber Deutsch und Englisch mit deutschem Akzent vernommen haben.

„Wir haben hier eine kleine Weile zu tun — warum wollen Sie nicht hereinkommen?“, fragten die „Raumfahrer“ nach Schmidts Angaben. Er sei der Einladung gefolgt und habe im Innern des Flugkörpers noch zwei Männer und zwei Frauen vorgefunden. Er sei durchsucht worden und nach 20 Minuten angeregter Unterhaltung habe er die Flugmaschine verlassen, die dann lautlos aufgestiegen sei. „Sie werden

später erfahren, was wir hier tun“, hätten die Besatzungsmitglieder noch zu ihm gesagt.

**UFO'S SERIOUS BUSINESS**

Unidentified flying objects - sometimes treated lightly by the press and referred to as "flying saucers" - must be rapidly and accurately identified as serious USAF business in the 21. As AFH 200-2 points out, the Air Force concern with these sightings is threefold: First of all, is the object a threat to the defense of the U.S.? Secondly, does it contribute to technical or scientific knowledge? And then there's the inherent USAF responsibility to explain to the American people through public-information media what is going on in their skies.

The phenomena or actual objects comprising UFO's will tend to increase, with the public more aware of goings on in space but still inclined to some apprehension. Technical and defense considerations will continue to exist in this era.

Published about three months ago, AFH 200-2 outlines necessary orderly, qualified reporting as well as public-information procedures. This is where the base should stand today, with practices judged at least satisfactory by commander and inspector:

- Responsibility for handling UFO's should rest with either intelligence, operations, the Provost Marshal or the Information Officer - in that order of preference, dictated by limits of the base organization;
- A specific officer should be designated as responsible;

# Polizist fotografierte unbekanntes Flugobjekt

**Amerikanischer Kongreß soll Untersuchung einleiten**

**Bad Axe/Michigan. (ap)** Scharen von unbekannten Flugobjekten müssen den amerikanischen Staat Michigan überquert haben. Einem Luftwaffenstützpunkt bei Detroit wurden Sichtungen aus fünf verschiedenen Landesteilen gemeldet. 


## Rätsel um „fliegende Untertassen“

Jugoslawische Experten bemühen sich um Identifizierung seltsamer Objekte

BELGRAD (dpa). Jugoslawische Experten bemühen sich gegenwärtig, das Rätsel um die in verschiedenen Teilen Jugoslawiens gesichteten angeblichen „fliegenden Untertassen“ zu lösen.

Mehrere Bauern hatten nach ihren Aussagen einen unbekannten Flugkörper über dem Berg Komovi in Montenegro beobachtet. Er sei so niedrig geflogen, berichteten sie, daß die Abgasflammen Wälder in Brand gesetzt hätten. Tatsache ist, daß die Wälder in Flammen standen und der Brand erst nach 24 Stunden eingedämmt werden konnte. Bewohner der Stadt Ivangrad, ebenfalls in Montenegro, wollen mehrere unbekannte Flugobjekte gesehen haben, die sich in symmetrischen Kreisen bewegten, ihre Höhe änderten und schließlich rasch davonflogen. In der ostserbischen Kleinstadt Golubac behaupteten mehrere Bewohner, sie hätten

einen „Himmelskörper“ beobachtet, der eine erheblich größere Geschwindigkeit als Düsenflugzeuge gehabt habe.

Rund 100 Einwohner von Pristina, der Hauptstadt der autonomen Provinz Kosmet, berichteten, sie hätten einen sternähnlichen Flugkörper von ungewöhnlicher Helligkeit gesehen. Verglichen mit einer zum selben Zeitpunkt sichtbaren Düsenmaschine sei er „in großer Höhe“ und mit viel höherer Geschwindigkeit geflogen. Dutzende von Menschen hatten in den letzten Tagen „fliegende Untertassen“ auch über Zagreb, Belgrad und anderen Gebieten des Landes gesehen. Am Dienstag hatte bereits in Sofia ein unbekannter Flugkörper Aufsehen erregt, der grell leuchtete und mit bloßem Auge über der Innenstadt sichtbar war.

# „Ufos nur Luftströmungen“ Sowjetforscher weist ausserirdischen Ursprung zurück

Sowjetische Wissenschaftler wollen jetzt eine natürliche, in ihren Einzelheiten allerdings noch rätselhafte Erklärung für unidentifizierte Flugobjekte (Ufos) gefunden haben. Begonnen hatte die Geschichte der Ufos vor nunmehr 35 Jahren am 24. Juni 1947 mit dem Privatflieger Ken Arnold, der behauptete, in den USA über dem Mount Rainier neun riesige glühende Scheiben von Untertassenform gesehen zu haben. Seitdem sind Zehntausende von Ufo-Meldungen um die Welt gegangen. Bei exakter Nachprüfung hatten sich durchaus irdische Erklärungen gefunden: fliegende Wetterballone, Flugzeuge und Wolkenfetzen im Schein der bereits untergegangenen Sonne, Reflektion von Schiffs-, Auto- und Flugzeugscheinwerfern an Dunst- und Wolken-Schichten, auch elektrische Entladungen.

Die Deutung von Professor Barenblatt ist anders: „Die (von den Strömungen erfaßten) Staubpartikel sind sehr leicht. Deshalb werden die Untertas-

sen auch mit halsbrecherischer Geschwindigkeit vom Wind fortgetragen, wie eine Boje in der Luft tanzend oder plötzliche Manöver wie vor einer Landung ausführend.“

Eine Zunahme der Staubeilchen kann nach dieser Darstellung den ganzen Strudelmech-

anismus mit einem Schlag beenden und die Scheibe abkippen lassen. „Damit brauchen wir uns auch nicht mehr länger um eine Interpretation für das urplötzliche Verschwinden der Ufos zu bemühen, denen ja die Fähigkeit zur unmittelbaren Beschleunigung auf Lichtgeschwindigkeit (300 000 km/h) nachgerühmt wird.“

Die amerikansiche Luftwaffe hatte für das Verteidigungsmini-

sterium in Washinton bis Ende der sechziger Jahre 12 618 rätselhafte optische Phänomene untersucht. Der Verdacht, daß einige dieser Erscheinungen außerirdische Flugobjekte gewesen sein könnten, ließ sich nie bestätigen. 701 Objekte aus dieser Untersuchungsreihe galten allerdings auch nach deren Abschluß als nicht identifiziert. Sinnestäuschungen und keine Gefahr für die nationale Sicherheit – so lautete damals das allgemeine Fazit.
